
✓ Your second question - regarding hostel fees - poses a problem. There is no mention of hostel fees on the file. I therefore cannot tell you whether they were included in his total fees of £55 or not. However, in my last letter to you I said that the file did not have a record of who paid the difference in his tuition fees, after his bursaries had been deducted. This information was not correct, as we have found three invoices for tuition fees for the three years Mr. Sobukwe was at Fort Hare, all addressed to a Mr G W Caley, Healdtown High School, Fort Beaufort, who appears to have paid the outstanding £15 each year.

As yours is an unusual request, I have passed on to you personal details from a student file which would not normally be available to the public. I know that you will treat this information with integrity, and I think it would be proper for you to attempt to contact Mr Caley (if he is still alive) before using his name in any publication.
