do hereby make oath and say that:-

1. I am an attorney of the Supreme Court of South Africa, duly admitted and practising as such at T.12 Nyambane Street, Galeshewe, Kimberley, in the Province of the Cape of Good Hope.

2. (a) I have read the Petition of the Petitioner, Robert Mangaliso Sobukwe.

(b) I confirm that the Petitioner entered into Articles of Clerkship with me as stated by him, and that he duly and faithfully performed his duties as such articulated clerk for the period from the 30th March 1971 to the 30th March 1974, and that he thereafter continued in my employ and is presently so employed.

- (c) I further confirm that the Petitioner served me continuously without interruption or break in his Articles, and that he was actually employed and worked in my office and under my personal supervision.
- (d) The Petitioner did not have any pecuniary interest in my practice during his said period of service under the Articles.
3. Immediately prior to taking the Petitioner under Articles as aforesaid, I had practised continuously as an attorney of this Honourable Court for a period of more than three years, and I practised as such attorney throughout the period of the Petitioner's Articles with me.
4. In my opinion, the Petitioner is a fit and proper person to be admitted and enrolled as an attorney of this Honourable Court.
5. I confirm having sought a written statement by the Minister of Justice that he has no objection to the Petitioner's admission as an attorney, and that I received from the Magistrate at Kimberley his letter dated the 24th March, 1975, which is Annexure "O" to the Petition.
