MISSION HOSPITALS.

Adverting to your letter No. JDRJ/EH of the 14th August, 1945, and my letter No. 9 of the 22nd October, 1945, I quote hereunder, for your information, an extract from a minute No. 179/315 dated 7th January, 1946, addressed by the Secretary for Native Affairs to the Secretary for Public Health :-

"It is observed that the Provincial Administrations are taking steps to work out formulae on which future assistance to mission hospitals will be based and that it is anticipated that the hospitals will in all cases receive more by way of such assistance than they receive at present from the provincial block grants and the South African Native Trust combined. As it is not anticipated that the formulae will be worked out in time to permit of their application during the financial year 1946/47, the Department is prepared to continue the grants from the South African Native Trust Fund to mission hospitals for that year on the same basis as in the past. These grants will, however, not be continued thereafter."

This office is still in communication with the several Provincial Administrations regarding the granting of financial assistance to Mission Hospitals after the 31st March, 1947, and you will be further advised as soon as finality is reached.

For your information, I may add that the Natal Provincial Administration has advised that "it has at present under consideration the general question of hospital services in this Province. Certain Mission Hospitals are carrying out functions which will conform to the Administrator's requirements; others will be required to modify or change their functions so as to conform to the general policy; others may be of no value in the Administration's scheme. In these circumstances the Administration can give no general undertaking at this stage in

Mission Hospitals.

With reference to your letter No. QW/EH of the 20th February, 1946, and previous correspondence relative to the above, I append for your information extracts from minutes received in the above connection from (1) the Provincial Secretary, Pretoria, and (2) the Provincial Secretary, Cape Town:-

(1) "..... as far as this Administration
(Transvaal) is concerned -

- (a) the Mission Hospitals, with Dr. R.D. Aitken as convener, have been asked to work out the subsidy on a per capita basis which will be required by them in respect of the free treatment of patients in Mission Hospitals, upon the introduction of free hospitalisation in the Transvaal, as contemplated in the Draft Hospitals Ordinance, 1946;
- (b) the submissions of the Mission Hospitals will thereafter be considered by the Administration and submitted for


consideration by the Administrator-in-Executive Committee. The draft ordinance referred to embodies a provision to permit of assistance to Mission Hospitals on a per capita basis in respect of the free treatment of patients;

(c) meanwhile this Administration will continue to support Mission Hospitals on a block grant basis to the extent deemed necessary to maintain their services, subject to other government departments making adequate contributions to the work as far as it concerns them."

(2) "..... the Administrator (Cape) has resolved that steps be taken immediately to implement the basis of financial assistance to private hospitals, namely, that, apart from patients suffering from tuberculosis, venereal diseases and formidable epidemic diseases, for the treatment of which private hospitals must obtain subsidy from the Union Government as in the past, this Administration agrees to assist private hospitals (including mission hospitals) in respect of the treatment of non-infectious cases by paying them a subsidy as from the 1st April, 1947, on a cost per patient per day basis according to the merits of each case, provided that it does not in any individual case exceed half of the average cost per patient per day in respect of that hospitals, and does not exceed half of the average cost per patient per day for the general hospitals in the whole province, and provided further, that the Provincial Administration shall appoint one representative on the governing committee or board of such hospital."

I trust that you will keep the Christian Council of South Africa and the Mission Hospitals' Board of the Dutch Reformed Church of the Transvaal posted of developments.

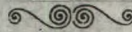

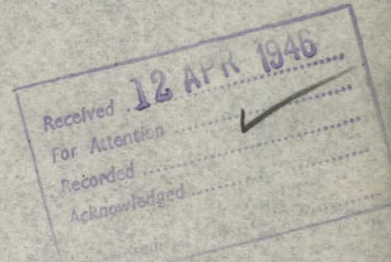

Dear Mr. Rheinallt Jones.

Many thanks for your letter of June 14th. received to-day, with its enclosure. Dr. Drewe, of Holy Cross Mission, has just returned from Capetown where he formed one of a deputation to the Select Committee of the Provincial Council. Even the Roman Catholics joined in, so it was a representative deputation.

We are fighting for greater assistance than a 50% maintenance grant. Apparently the Provincial Executive thinks only in terms of what the 2/6 tax will bring in, and are inclined to say 'We shall only get £32,000 from this tax in the Transkei, and therefore we are only going to spend that.' This seems a thoroughly bad principle to adopt, and also it carefully ignores the fact that, so we are told, the Province will get £ for £ from the Union Government.

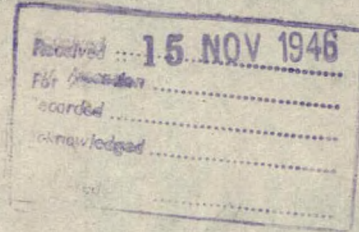

Further to my letter of the 11th inst., re the above, I have to apologise for referring therein to the Central Government instead of the Cape Provincial Administration, and have to amend the wording thereof to the following:—

"That it was the feeling of the Committee that the Provincial Administration, having accepted the responsibility for the provision of hospital services in the Province, pressure should be brought to bear to have this policy implemented and to ensure that the Administration provide adequate hospital facilities for all sections of the population including Africans. Therefore, the Committee urges that the Administration must be prepared to accept the control and maintenance of the mission hospitals. Should the Administration not be in a position to do so immediately, it should nevertheless make this offer to the mission bodies concerned and indicate the date on which it will be in a position to accept control of their hospitals. The response of the mission bodies to this offer should then determine the basis on which subsidies are allocated to them. To those bodies which indicate their readiness to relinquish their control, a 100% subsidy on maintenance costs of free patients should be made during the interim period; whilst those who declare their intention of retaining control should only be subsidised to the extent of 50% in terms of the provisions made under the Hospital Ordinance."

At the meeting of the Regional Committee held on the 8th November, Dr. Luke addressed the members on the implications of the Cape Hospital Ordinance. After discussion and consideration of the position of the Mission Hospitals, the following decision was reached :-

Provincial Administrations

"The Government, having accepted the responsibility for the provision of health services for all, pressure should be brought to bear to have this policy implemented and to ensure that in the matter of hospital services, the Government, through the Provincial Administrations, provide adequate facilities for all groups, including Africans. Therefore the Committee urges that the Government must be prepared to accept the control and maintenance of the Mission Hospitals. Should the Government not be in a position to do so immediately, it should nevertheless make this offer to all the Mission bodies concerned and indicate the date on which it will be in a position to accept control of their hospitals. The response of the Mission bodies to this offer should then determine the basis on which subsidies are allocated to them. To those bodies which indicate their readiness to relinquish their control, a 100% subsidy on maintenance costs of free patients should be made during the interim period; whilst those who declare their intention of retaining control, should only receive be subsidised to the extent of ~~the~~ 50% in terms of the provisions made under the Cape Hospital Ordinance."
