Dear Ian,

Thank you very much indeed for your letter of 20th January, 1954, and for the Durban International Club Report and Annual Accounts. These I will forward immediately to the Phelps-Stokes Fund saying that the next Annual Report will be forwarded.

Actually, I believe the Phelps-Stokes Fund has already made another tentative allocation to the Club, but did not wish to make it a decisive allocation until it had received the reports. Frank Loescher, who visited the offices of the Fund, reported very favourably on your work.

I agree that it would be best if the Club were independent of outside support except for emergencies, though acceptance of such outside emergency help breaks the principle of complete self-support. When I discussed the grant to the Durban International Club with the Fund and with Ken Kirkwood, I suggested (to both) that any amount donated should be kept for special projects, i.e. in reserve until something which seemed particularly desirable came along. In that way, I felt the Fund donation would not go to current revenue and expenditure. I know how useful such a special reserve fund can be.

You say that you will oppose any fresh application "at present". My experience of the Fund is that if they decide to support anything, they send the grant annually without annual application provided satisfactory reports are submitted.

P.T.O.

Dear Mr. Rowe,

I enclose the Annual Report and Accounts of the Durban International Club for 1951-1952. The Report and Accounts for 1952-1953 will be sent as soon as the Annual Meeting is held and the Accounts audited. As you will see the Club had difficulties over premises and there was considerable disruption of activities. The new premises are an improvement and the furniture and equipment, in no way extravagant, a great asset.

You will remember that I suggested to the Fund and to the Chairman, Ken Kirkwood, that the grant from the Fund should be kept for special projects and not incorporated in general revenue and I think that the grant was well spent in equipment. The Club Executive also, I think, takes the view that the Club must try to support its own current activities by its own efforts, keeping the Fund grant to finance specially desirable projects. I hope that the Fund will agree to this for I think it is a healthy sign and the "reserve" of a sum that can be called on is, as you know, a great asset.

Even although the "spread" of the Club outwards is not great, I consider its very existence important and I would endorse Frank Loescher's recommendation that it continue to be supported.



Dear Mr. Rowe,

I write to acknowledge receipt of \$500.00 for the Durban International Club, receipt for which is enclosed.

I am very glad indeed that the Fund has seen its way to help the Club once more. You will, I am sure, appreciate how difficult it is at this time to maintain such a Club in existence in South Africa and how necessary it is as a symbol of possible racial co-operation here. With the recent government success in our provincial elections, we may expect that much greater pressure will be put upon those of us who have an integration approach to our racial problems.

It was lovely seeing you all again and that "tea" was altogether delightful - I quote it as the highlight of American hospitality and friendliness. After the sunshine of Hawaii racial peace, the clouds of South Africa descended on my return with two Cabinet Ministers attacking the Institute and my own name in four-column headlines in an Afrikaans paper. It is all going to be very difficult - the more so as the Non-Whites are turning to communist or near-communist leadership for help. However, it is all part of the battle which interludes like a visit to the United States give one courage and strength to continue.
