A promused report!

which have just had our "leadership" training weekend, which was an overall success. We still didn't get as for as climbing the mountains sogether, though! It was attended by evec, campus and 2 reps from each sub-committee. We went through an analysis of the state of the Nation, booking particularly at implications for ecc; the qualities and role of sub-com co-ordinators, identifying skills we need to develop, ecc's methods of working and also getting a thorough overall picture of activities, problems, strengths and mood in all the various parts of ecc; fixally we discussed the Day of Action and "R25" in detail. I think we came home with a deeper sense of unity and with an understanding of ecc as a whole, which seems to have been eaching since the s. of E.

Let me start with the Day of Action, which hasn't yet gone through full sub-come discussion, so this is based largely on the weekend away and exec perceptions. Essentially people came out with the same position as N.C. with respect to the nature of our participation, a joint call from national white organisations and linking our participation to ECC demands. As far as action goes, Joburg thinks we should not have a fast now, and should go all out for yellow ribbons. My feeling is that this may need to be rethought since it now looks as if this Day of Action woult happen for at least another mouth, and we had planned the yellow-ribbon campaign linking up 125 and the Day of Action.

We will be seeing UDF people this week about our participation in the campaign. You have next probably heard reports from

the Cosatu CEC, when the Day of Action was in fact discussed for the first time within Cosatul and a decrsion made to take the idea back to the gransoots, suplain it thoroughly and organix around it before engaging in Action. So there is as yet no concrete date for the Day. Confusion also seems to exist amongst comrades + organisations as to whether the call is for a Day of Action or a day of Closure. I think it make a difference to our participation + approach, but we need to try to get clarity before discussing it.

to far as Right to speak goes, we have planned a fairly public campaign which was intended to link up with and lead up to the september Day of Action. It would involve * A VIP action (local nobs, reps from affiliates and a sample of brave conscripts) go to wits Command + place yellow flowers in gun barrels + spend time talking to the soldiers on duty, about their right to choose, to refuse township duty, to have alternatives etc.

* A week later, a public meeting (originally to be just before the Day of Action)

* A cabaret evening (featuring Jennifer Fergusson + the likes and devised especially for us) somewhere in the N. Subs?

* Church congregations 'adopting' an Ecc detained + a similar township detained; they would use comparison of their backgrounds + pamphlets to explain each's position, + have amnesty candles lit in their memory.

* National Advert + pamphlet (this would be taken door-todoor in specified areas)

Campaign. In a fit of unrealistic excitement we even went so for as to decide to get a Johnny Closs type to rewrite the original song and cut a 7-single. which we would get to the top of the Charts! the SRC, after a very successful campaign is which ecci profit on campus increased dramatically. To you know, it was a very dirty election, and we definitely have problems to deal with as a result. But all under combol.

Wits people have been convinced to do votional campus Goord, so can we have names + phone numbers please? They also came up with the idea of sending around amateur videos of the people in various campus ecc's working talking etc., so that other campuses can get an at-a-distance feel for studen ecc activity and faces. the Jo'burg adress.

Tuesday evenings between 7.00 and 8.00 is going to be difficult time for me to take calls. I would prefer it if you could phone instead on Wednesdays. The days to phone then would be Sundays, Wednesdays and Thursdays. Please phone at least once a week even if there is nothing specific for you to report.

News.

The evidence to the Un Human Rights Commission has been sent off. It was a brief rundown of the effect of the emergency provisions on ECC and direct repression. It also highlited conscription as denying fundemental huma rights and also placed emphasis on the denial of our right to speak. We got quite good press out of it in Jhb. How did it go in your region.

We have received a letter from Dennis Healey saying how good it was to meet with Adele and that he referred to us in his report to the British Parliamentary Select Committee on South Africa.

The lawyers are busy assessing our case. The major angle they are talking about at this stage is to concentrate on the notion of "incitement" contained in the clause which refers to "compulsory military service" in the emergency regulations. They would argue that one can only incite another to engage in an illegal activity. Since it has never previously been illegal to oppose conscription the would challenge the regulation onthat ground. Also it is a perfectly legitimate thing to do . In support of such an argument we would present affidavits from the following people: Dennis Hurley, Mary Burton, Richard Luyt, Stuart Saunders, Colin Eglin and Rabbi Franklin. What do you think of the list? We tried not to duplicate categories of people, and sought to find the most eminent people on our nobs list. A further person who was added to the list was Nthato Motlana who would provide a "black perspective" on the role of the SADF and on conscription.

sanction (sangk- shun) n. solemn ratification; express permission; authorisation; approval; <u>legal use of force to secure obedience to law; anything which serves to move a person to observe or refrain from given mode of conduct.</u>

Now isn't that something. I had just popped into the library to take my daily reading from the dictionary when, lo and behold, my eye befell the above wonderous extract.

Sampan (sam´-pan), samphire (sam´-fir), and sample (sam´pl) had been interesting. Samurai (sa´-mòò- ri) was frightening, while sanable (san´-a-bl) gave me feelings philanthropic. "Sance-bell. see sanctus-bell" quite frankly, left me cold. And then I saw it - sanction. Now isn't that a word to send shivers down your spine; and to intensify the hot and cold flushes, I was overcome by sanctions n.pl. and sanctionary a. To top it all I learned that the etymological root of this most special set of words was sanctus, the Latin for "holy".

Now the ECC, as you well know, does not have a position on sanctions. And this is despite Steven having views to the contrary. Surely this has to do with the Roman root of the word.

The point of this introduction is twofold, actually threefold. Firstly I suppose I had to think of something snappy to start my letter with. Secondly I thought it was quite interresting that the definition of sanctions can be used to describe the system of conscription. So if we are running into severe problems with the legal space in which we work we can always reorient ourselves and change our name to the End Sanctions Campaign. Not only will this allow us the space for a broad campaign but it will introduce us to a new and untapped constituency in the white community i.e. all those who oppose the dreaded sanctions. I suppose, though, that we would have to give our campaign some content to explain exactly where we are coming from. (Isn't it amazing what one can do with a bit of jargon). We will of course also have to consult with our nobs, including the new Archbishop. The third reason is that Steven is entering the earlier stages of apoplexy about our financial affairs. So remeber what sanctions really mean in ECC circles.

This letter is actually about all different kinds of things which I have have arranged under different headings for your reading pleasure.

National Day of Unity

We met with the UDF, providing them with a report of our ideas, as well as gathering new information from them.

Most importantly we were told that the date for the day of unity was going to be moved to the end of October at earliest. This was largely due to the need to accomodate the COSATU exec's wish that there be thorough consultation and discussion within their ranks at the factory-floor level. They did not wish to repeat the problems associated with the July 14 stayaway.

An aspect of the national day which was clrrified was its tone. Rather than it being a day of ungovernability it is rather being seen as being more "dignified". In this vein there is the idea for it to take the form of a national day of prayer or of fasting. The intention is that this kind of approach will lessen the liklihood of the day assuming a mood of confrontation.

The people we met with were happy with our ideas re yellow ribbons, the fast and our call to other white organisations to support the call for unity.

I have still not had a full report from all the regions as to how you are feeling regarding ECC supporting the call. Could you please let me know?

Yellow Ribbons/Fast/Right to Speak

What's happening, exê? Is your region taking these issues up? If so, what ideas do you have in mind? And what kind of content is going into it? Similarly for the Right to Speak campaign.

We had agreed that these focusses would be decentralised, i.e. that regions would work out their own programmes, and we would have national coordination around media, the ad, and the date of the fast (if regions agree to it). There is a lack of clarity around these issues at present. I think that the best way of clarifying it would be for regions to send around their ideas, plans and feelings. These can then be pulled together and discussed.

Harrasment

Well parliament has sat and unsat itself. You know, sometimes I wonder where some of the members of that hallowed institution learned the skills of sitting the right way up on a bench; but anyway that's beside the point. The point in fact is that we have sat through a parliamentary session without delivering our much anticipated harrasment document. Some regions have still not submitted their details; we can't proceed without these. Any ideas how we can use the document once it has been compiled?

Leagal

1) The return of Gabs Malan:

Remeber her? She was the one who got a prime spot on SATV News to conduct a tirade against us. Anyway she's at it again with the enclosed pamphlet. It was distributed to a Std 9 class at Glenn High School in Pretoria. Andrew Pearce, a lawyer at Bell, Dewar and Hall has written her a stinker of a letter contesting about 15 points of fact and opinion in it. He also threatens her with legal actin. He has suggested that we first proceed with the Aida Parker case before following up on this one.

2) Aida Parker here we come department

Bob Steyn of the Media Council did us a wonderful turn by discovering that the APN is in fact registerd as a newspaper. As such it is subject to the jurisdiction of the media council. This means that we will after all be taking up the case in the Media Council. A hearing has been set for October 6 in Cape Town.

Dave Dison, assisted by Andrew Pearce will be our lawyers in the council. Dave says that our case would consist of affidavits concerning the contested facts in APN 79, as well as evidence in chief given by Laurie. Someone from ECC would need to be prsent throughout to give assistance and direction.

A further point is that we should maximise our publicity around the case. A major aspect of it would be to have a large and coordinated media presence at the hearings, which Dave says could run for a few days.

We have to sign a waiver in which we agree that we will not take the matter of APN 79 to any other court. This is a formal requirement of the media council.

Dave feels that we should conclude this application before proceeding with our challenge to the emergency regulations. He intends to include in our case in the council a focus on the fact that the APN has been used by the Branch (and thus the state) as a source to argue why ECC people have been detained. The Grahamstown judge who ruled in that case, rejected the APN after Dave Dison filed an affidavit about it. This fact will,

no doubt, count in our favour inthe council.

It is around this point, i.e. the link between the state's use of the APN in arguing why it has taken action against us under the emergency and our eefectively exposing the lies in the APN, that we can gain maximum publicity. By defeating the APN in Media Council we will be publicly defeating the arguments that the state uses against us. Much more than simply taking on the APN we are taking on the state. This is why we have to super hype this case.

Could your region discuss all the issues around the APN matter?

Vula!

We have been offered the possibility by Vula! of placing an insert in their next issue. The cost to us would be that of the 10000 leaflets we would print as inserts. As Vula! is a national publication, it is important that all regions consider whether we should do it; and if so, what kind of content should it have?

International

Two items of news here. The first is that we have received a telex from WRI asking us whether it will be alright with us if next year's internatinal CO day which is on May 15 focusses on South Africa. They would like a response from us, so could your region discuss it?

The second item is that we met with the second in charge at the French embassy. He gave us a very sympathetic hearing and will try to bring French prssure on Janet's case. It was best to focus on Janet because of her French links and experience.

Birthday

Anyone know when ours is? We in Joburg are thinking of using the declaration launch date of October 14. There is an idea that we should do something public on the day. A fuller motivation will follow. What do you think?

Campus coordination (!)

With the university year fast drawing to a close we have an agreement from the Wits ECC to do phoning around between campuses. They however need the names and phone numbers of the campus contacts around the country. Could you please send these to me?

Hi all

I am writing this letter on a most beautifull first day of spiring. All is well considering the conditions. We have seen no action from the state since Janet's detention. There are applications underway for the release of Nike Loewe in Port Elizabeth, Karen Thorne and Mellisa deVVilliers in Grahamstown, and in a seperate application for Bridget Hilton-Barber also in Grahamstown. The papers have been presented to the court and we are at the moment awaiting the outcome of the applications. In Karen's case she wrote an affidavit which was put before the court which outlined an incident in which one of her interrogators, a Grahamstown security policeman by the name of Lloyd Edwards made sexual advances to her in her cell. Edwards is well known in Grahamstown as he used to be involved in NUSAS during his student days. After leaving campus he re-emerged as a member of the security police. His older brother, Carl, is also in the Branch.

There was another humourous incident involving Edwards when Peter Vale, the husband of another Grahamstown detainee Christine Vale, emptied the contentents of a beer bottle over Edwards' head when he bumped into him a few weeks ago in a pub im the town. Peter was found guilty of the act and fined R10,00. Much more significant than the fine has been the appearance around Grahamstown of posters with the legend "Down a Lloyd, and feel satisfied".

ECC work at the moment is largely related to getting our "right to speak" campaign going. We are approaching it from the point of view that we need to be engaging in far more public work than we have done up till now during the emergency, Weefeel the need to test the space that is available to us to engage in public work. Practically, this means that we will be involving ourselves in a series of activities which are increasingly overtly public in their nature. From a media campaign to start with we will progress to public meetings and so on. Conditions vary from centre to centre and as such the activities will as well.

A number of thongs have already been started. We have printed about 40 000 post cards adressed to PW Botha and to Colin Eglin calling on the government to end the silencing of ECC. The postcards to Eglin are largely as proof that PW has been sent a copy. We have started to distribute these. I have enclosed a few copies for you. Is it possible to distribute these internationally?

The statement "We call on the Government to recognise Freedom of Conscience" has been en endorsed by a number of prominent individuals. I have enclosed a copy of the list. We are at present attempting to place the statement together with the list of endorsers as an advert in a number of newspapers. We have run into difficulties with a number of papers whose lawyers have turned down the ad as they are afraid that while it is not subversive, it might lead to administrative action being taken by the police. They are afraidethat the edition of the paper carrying the ad might be taken off the streets by the police. The papers say they are waiting for the outcome of the SAAN/Argus applicationagainst the state of emergengy before they might publish the ad. This kind of reaction is symptomatic of the behaviour of the commercial liberal press at the moment. They appear not be prepared to challenge the state in any substantial way at present. Even after the state gave permission to the papers to once again carry news of unrest which was not first cleared by the Bureau for Information the atar still carried a front page imprint which says that tehy were restricted inthat the Bureauocoontrolled the flow of informations.

With respedt to the press, we have been conducting a vigourous campaign of attempting to get coverage. We have put out many prees releases and have built up good relations with a numbee of journalists. We have seen results with some good coverage. The clips from around the c country are being pulled together at the moment, and as soon as they are compiled I will send you a copy.

Ther are also other ideas to promote the right to speak campaign being developed in centere around the country at the momentt They are largely to do with the production and distribution of media.

There have been a number of public meetings lately in which ECC has participated. In Johannesburg we participated in an ad-hoc grouping called the Cpalition for the Right to Know. As you will no doubt have gathered whe coalition focussed on the denial of free free speech under the emengency regulations. There was a very successful public lunch-time meeting held in the Jo'burg City Hall attended by about 1000 people, mostly from the business sector. ECC prescence at the meeting consisted of an ECC rep sitting on the platform and also am ECC pamphlet put out for the meeting. In Pietermaritzburg and Durban there have been similar meetings called by coalitions which included ECC. At both there were ECC speakers who both went down very well with the audiences. A Attendance at both exceeded expectations. About 400 people attended each meeting. The meetings, particularly those in Natal, were a useful test for us of what we are capable of doing at present. There was a large accurity police presence at the Durban meeting, yet no action was taken.

This Thursday we are holding a meeting in Cape Town, entitledEEECC Speaks". It is thus an ECC meeting specifically and there will be an ECC Speakes, as well as Di Bishop and Alex Boraine. Ivan Thoms is to chair the meeting. I will let you know more about i it next week.

Another significant area of action around the right to speak theme will be our possibly bringing a Supreme Couth action to challenge that aspect of the Emergency Regulations wh which directly affects us. Our Lawyers are asking us to hold on this at the momnet as the they are awaiting the outcome of the SAAN/-Argus application. That application has ald challenged the clause which limits our work, amongst other challenges it is making.

Still on the legal front, we are still bringing an action against the Aida Parker News-letter in the Media Council. This has however run into bureacratic difficulties in te the Council with the effect that ther is a slowing up in the proceedings. We are pushing our lawyers as best we can to speed up the proceedings. A similar attack to t that made on us by Aida Parker has just been published by Gabs Malan who heads the 500 000 strong vrouefederasie. The 16 page document written by Malan is entitled "The Dangerous Game (of the ECC To end conscription)". It is published by an organisa isation called Women for South Africa. We are following it up with the lawyers.

A final item of news is that the Defence Act is at present being ammended. The proposed ammendment aims to narrow the definition of "religious" in terms of religious objectors. The ammendment now defines someone as religious only if their beliefs are based in the belief in a supreme being. Previously this has not been so narrowly defined. The effect of this is that someone ,lilike Dave Hartman a Bhidist, will no longer qualify for alternative service as he just has following the Supreme Court ruling in his favour. The ammendment indicates a clear hardenning in the attitude of the state.

With the rent boycotts and the school conflict intensifying in the townships, the situation here is reaching another peak. Just last week 30 people were shot by the police in Soweto in a few days of struggle related to rent evictions. In the schools there is a constant ptesence of SADF troops. This has led to boycotts in many schools. The troops have taken the responsibility of maintaining "law and order" in the schools with the obvious effect of incensing the students. They have been involved in the execution of corporal punishment, of barging into classes and removing students, as well as ordering teachers to do things such as discipline classes they are not responsible for. The National Education Crisis Committee, the UDF, and COSATU have all made calls for the troops to get out of the schools. We have also made public calls to this effect

As you can see the struggle continues! Yay.

So if we are running into severe problems with the legal space in which we work we can always reorient ourselves and change our name to the End Sanctions Campaign. Not only will this allow us the space for a broad campaign but it will introduce us to a new and untapped constituency in the white community i.e. all those who oppose the dreaded sanctions. I suppose, though, that we would have to give our campaign some content to explain exactly where we are coming from. (Isn't it amazing what one can do with a bit of jargon). We will of course also have to consult with our nobs, including the new Archbishop. The third reason is that Steven is entering the earlier stages of apoplexy about our financial affairs. So remeber what sanctions really mean in ECC circles.

This letter is actually about all different kinds of things which I have have arranged under different headings for your reading pleasure.

National Day of Unity

We met with the UDF, providing them with a report of our ideas, as well as gathering new information from them.

Most importantly we were told that the date for the day of unity was going to be moved to the end of October at earliest. This was largely due to the need to accomodate the COSATU exec's wish that there be thorough consultation and discussion within their ranks at the factory-floor level. They did not wish to repeat the problems associated with the July 14 stayaway.

An aspect of the national day which was clrrified was its tone. Rather than it being a day of ungovernability it is rather being seen as being more "dignified". In this vein there is the idea for it to take the form of a national day of prayer or of fasting. The intention is that this kind of approach will lessen the liklihood of the day assuming a mood of confrontation.

The people we met with were happy with our ideas re yellow ribbons, the fast and our call to other white organisations to support the call for unity.

I have still not had a full report from all the regions as to how you are feeling regarding ECC supporting the call. Could you please let me know?

Yellow Ribbons/Fast/Right to Speak

What's happening, exê? Is your region taking these issues up? If so, what ideas do you have in mind? And what kind of content is going into it? Similarly for the Right to Speak campaign.

We had agreed that these focusses would be decentralised, i.e. that regions would work out their own programmes, and we would have national coordination around media, the ad, and the date of the fast (if regions agree to it). There is a lack of clarity around these issues at present. I think that the best way of clarifying it would be for regions to send around their ideas, plans and feelings. These can then be pulled together and discussed.

Harrasment

Well parliament has sat and unsat itself. You know, sometimes I wonder where some of the members of that hallowed institution learned the skills of sitting the right way up on a bench; but anyway that's beside the point. The point in fact is that we have sat through a parliamentary session without delivering our much anticipated harrasment document. Some regions have still not submitted their details; we can't proceed without these. Any ideas how we can use the document once it has been compiled?

Leagal

1) The return of Gabs Malan:

Remeber her? She was the one who got a prime spot on SATV News to conduct a tirade against us. Anyway she's at it again with the enclosed pamphlet. It was distributed to a Std 9 class at Glenn High School in Pretoria. Andrew Pearce, a lawyer at Bell, Dewar and Hall has written her a stinker of a letter contesting about 15 points of fact and opinion in it. He also threatens her with legal actin. He has suggested that we first proceed with the Aida Parker case before following up on this one.

2) Aida Parker here we come department

Bob Steyn of the Media Council did us a wonderful turn by discovering that the APN is in fact registerd as a newspaper. As such it is subject to the jurisdiction of the media council. This means that we will after all be taking up the case in the Media Council. A hearing has been set for October 6 in Cape Town.

Dave Dison, assisted by Andrew Pearce will be our lawyers in the council. Dave says that our case would consist of affidavits concerning the contested facts in APN 79, as well as evidence in chief given by Laurie. Someone from ECC would need to be prsent throughout to give assistance and direction.

A further point is that we should maximise our publicity around the case. A major aspect of it would be to have a large and coordinated media presence at the hearings, which Dave says could run for a few days.

We have to sign a waiver in which we agree that we will not take the matter of APN 79 to any other court. This is a formal requirement of the media council.

Dave feels that we should conclude this application before proceeding with our challenge to the emergency regulations. He intends to include in our case in the council a focus on the fact that the APN has been used by the Branch (and thus the state) as a source to argue why ECC people have been detained. The Grahamstown judge who ruled in that case, rejected the APN after Dave Dison filed an affidavit about it. This fact will,

no doubt, count in our favour inthe council.

It is around this point, i.e. the link between the state's use of the APN in arguing why it has taken action against us under the emergency and our eefectively exposing the lies in the APN, that we can gain maximum publicity. By defeating the APN in Media Council we will be publicly defeating the arguments that the state uses against us. Much more than simply taking on the APN we are taking on the state. This is why we have to super hype this case.

Could your region discuss all the issues around the APN matter?

Vula!

We have been offered the possibility by Vula! of placing an insert in their next issue. The cost to us would be that of the 10000 leaflets we would print as inserts. As Vula! is a national publication, it is important that all regions consider whether we should do it; and if so, what kind of content should it have?

International

Two items of news here. The first is that we have received a telex from WRI asking us whether it will be alright with us if next year's internatinal CO day which is on May 15 focusses on South Africa. They would like a response from us, so could your region discuss it?

The second item is that we met with the second in charge at the French embassy. He gave us a very sympathetic hearing and will try to bring French prssure on Janet's case. It was best to focus on Janet because of her French links and experience.

Birthday

Anyone know when ours is? We in Joburg are thinking of using the declaration launch date of October 14. There is an idea that we should do something public on the day. A fuller motivation will follow. What do you think?

Campus coordination (!)

With the university year fast drawing to a close we have an agreement from the Wits ECC to do phoning around between campuses. They however need the names and phone numbers of the campus contacts around the country. Could you please send these to me?

Hello,

Thank you for the note that you sent us.

We are all doing well. There has not been any state action against us for some weeks now and while the situation has not returned to normality again there does seem to be a more relaxed attitude in ECC circles around the country. The Eastern Cape and Joburg are still encountering the greatest threat of repression. Durban, Pietermaritz-burg, Stellenbosch, Cape Town and Pretoria are experiencing conditions in which one would think that there were no emergency.

Three of our detainees have been released. They are Karen Thorne from Grahamstown, Mike Loewe and Sandy Stewart of Port Elizabeth. Mike and Sandy have been issued with emergency banning regulations which effectively bar them from participating in political activities. Despite this they are all well and raring to go. We have received news of Janet and that is that she is well and has been taken out of solitary confinement and placed with two white women detainees from Grahamstown viz., Anne Burroughs and Louise Vale. We have approached the French Embassy here for assistance and pressure in Janet's case. They gave us a sympathetic hearing due to Janet's ECC work in France earlier this year. Regarding Dominic, we have heard that his Mauritian passport has expired and that he is not to be issued with a new one. This effectively jams up the bureaucratic works for the South African authorities. It should provide the time and opportunity for pressure to remove his deportation order.

We are at the moment in between intensive periods of public work. We held a successful meeting in Cape Town entitled ECC speaks which was attende by 7-800 people. While this figure is well below the 3 or 4000 that ECC people in Cape Town have become accustomed to, it was good considering the fact that the white South African public have been very frightened by the state of emergency and can not be relied on to come forward in big numbers. The speakers, Alex Boraine, Di Bishop and ECC's Nic Borain were very well received. There was an enormous amount of media distributed around Cape Town as part of the run up to the meeting. In Cape Town then, we have reestablished a strong public presence. This ties in very well to our right to speak campaign in that we are demonstrating our right to speak by speaking out on a range of issues and at the same time pointing out those issues we have been forbidden from speaking about.

In Grahamstown, Pietermaritzburg and Johannesburg we have distributed a whole lot of media about our right to speak. I have included some of this. We are also shortly to be running a campaign in Jhb with a dual focus: firstly we will be calling for the right to speak; and in the second place protesting at the fact that troops are in the townships. This campaign which will have a large media component, use yellow ribbons as a symbol of our call for a troop withdrawal from the schools will culminate with a public meeting. This meeting is being seen as a testing of the legal ground on which we operate. People in Durban are looking at a focus with the theme of "Is the war worth the cost of fighting it". Also in Durban there is a new issue of the very good publication "At Ease" about to start rolling off the presses. They are also planning a dinner on October 19 to celebrate three years of our existence. They are expecting about 250 of our close supporters to attend the dinner and intend to have a speaker adress the gathering.

Perhaps one of the most exciting aspects of our work at present is the growth and consolidation of our branch in Pretoria. As you know Pretoria is the heartland of the white South African military machine. Any development of white resistance to apartheid is thus a very exciting development in the city. We are most pleased that the ECC group

there is pulling together very well, and after only a few months of being in existence is planning a public campaign around the right to speak theme.

In an earlier letter I wrote about our possibly taking the state to court, challenging it around the emergency regulations that restrict our work. We were also in the process of bringing an action against the Aida Parker Newsletter. At that stage we were in the process of presentin argument to the Media Council as to why we felt the APN should fall under the jurisdiction of that body. This followed Aida Parker refusing to subscribe herself to its authority claiming that only registered newspapers were obliged to do so. It has since transpired that Aida Parker by doing this had in fact lied to the council as it has some discovered that she is registered as a newspaper. This has meant that the case is going ahead on the 6th of October in Cape Town. Our lawyer is very confident of our succeeding in the case. We have decided to conclude this case before bringing any further action against the state.

By taking Aida Parker on in this way we are in effect taking the state on as regards the arguments it uses against ECC. In the recent application for the release of detainees in Grahamstown security police pointed to the argument in the Aida Parker Newsletter as a basis for their detaining members of ECC. A number of right wing publicatons with close links to the state have quoted from the newsletter. Our case against Aida Parker then is more than a simple matter between us and her. It in fact assumes the proportions of an ideological challenge to the state. If we win, which we are confident of doing, it will mean that we are setting back the state's attack on us in a significant way. We thus stand to gain a great deal from this action. As a result we also intend to have a big media drive around the hearings.

Justin Hardcastle is set to arrive in Britain on September 28. He is going to register for the course he is taking on the following day and would like a couple of days to settle in. He would be available to start with activities for ECC from October 1. It might be useful for you to start drawing up some form of itinerary for him now although you could work out the details with him when he arrives. He will be available to do high profile work, such as speaking engagements and press work. He is very good at this kind of thing.

It was a shame to hear that you had not received the outline of the book. Laurie had sent a copy directly to your offices. I have included a copy of it with this letter. A point about the progress of the outline is that when Janet was detained a copy of it was taken by the security police. This is not very serious but it is important that you know.

Thank you very much for starting to work on our mailing list. I should be sending another letter for international distribution shortly. The following are a few more names for the list:
