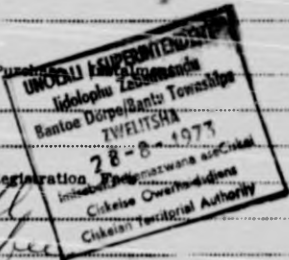

(j) THE MANAGER OR HIS DEPUTY MAY ENTER THE HALL AT ALL TIMES.

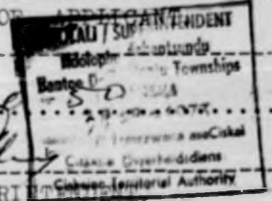
