Malan Challenge To A.N.C.

JOHANNESBURG

In a brilliant address to an audience of 500 people at the Donaldson Centre, Orlando, Dr. Njongwe, acting president of the African National Congress in the Cape, traced the history of 300 years of trickery and insincerity of the ruling class of South Africa.

He declared that the attitude of the European since his arrival in South Africa has been one of reducing Africans to slaves and maintain them in that position. This outlook was the dominating factor in all legislation passed since the days of Sir George Grey, when Africans fought in the war but were excluded from the Vereeniging Peace Conference. The passing of the 1913 Land Act, which turned the entire African population into a large wandering landless and poverty-stricken mass. The passing of the Urban Areas Act, which the African received as a reward for fighting in the 1914 war, and the Urban Areas Consolidated Act of 1945, the reward for fighting Hitler's armies.

On many occasions during Dr.

On many occasions during Dr. Njongwe's address the audience burst out into spontaneous singing of "Nkosi Sikelele Afrika" and punctuated his speech with cries of "Afrika!"

LEGACY OF SLAVERY

In concluding his speech Dr. Njongwe said, "Dr. Malan's oppressive laws constitute a moral challenge to the African National Congress. It is for this reason that we have decided to embark on the campaign for the Defiance of Unjust Laws. We dare not retreat now. If we do we shall have left our children a legacy of slavery, and we shall never rise again."

Swart Gives Birth Again

The Minister of Justice, Mr. C. R. Swart, gave birth to one of his "own babies" for the second time this month when he opened a farm prison for hiring out convicts at Caledon in the Cape Province. The other one was opened in the O.F.S. three weeks ago (SPARK, August 22).

The latest prison was built by the wine farmers of Caledon area.

To date South Africa has 15 of these private jails—13 in the Transvaal, one in the O_F.S. and the latest in the Cape.

A GALLANT FIGHTER!



Miss Amina Asvat, vice-chairman of the Transvaai Indian Youth Congress, is at present serving a sentence of two weeks hard labour together with 24 other women who defied permit regulations at Germ ston Location. Miss Asvat is 20 years old. She left her job when the campaign for Defiance of Unjust Laws started on June 25, to become a full-time worker for Congress. Amina comes from a family whose fighting tradition is well known. Her father was a close associate of Mahatma Gandhi and played a prominent part in the first patsive resistance struggle in South Africa. Her sister Zanap, was a courageous fighter in the 1936 passive resistance struggle. She served several terms of imprisonment for defying the Ghetto Act of the Smuts Government.

Dismissed Teachers Students Boycott School

Events took a dramatic turn when the three dismissed teachers of Orlando High School were arrested outside the school and detained for three days at Marshall Square Police Station. The men, Messrs. Zeph Mothopeng, president of the Transvarl African Teachers Association; E. Mphahlele, secretary of T.A.T.A., and I. Matlare, editor of the T.A.T.A. press, were charged under the Riotous Assemblies Act with incitement and were released on hall £15 each. The men will appear at the Johannesburg Magistrate's Court on September 8.

PEOPLE'S SCHOOL

A people's school has been organised for the students of Orlando High who have refused to return to school until the three dismissed teachers have been reinstated. Members of the Student Liberal Association have volunteered to run the People's School.

PARENTS PROTEST



Berrange Attacks Government

JOHANNESBURG

In a forthright and brilliant address to the Court at the end of the Preparatory Examination of charges against Dr. Moroka, Dr. Dadoo and 18 other non-European leaders, defence counsel Vernon Berrange exposed the real aim of the authorities in instituting these charges under the "Suppression of Communism Act."

POLITICAL CHICANERY

Referring to the Suppression Act Mr. Berrange stated: "To put it bluntly, it was openly said that the reasons for passing this Act were completely hypocritical and opportunistic—that the title thereof had no relation to the realities of the political motives. These allegations were strenuously denied. The institution of the present proceedings gives the lie to those who made these denials—it confirms those who regarded such denials as being what they so obviously were—nothing but political chicanery.

GOVERNMENT DESPERATE

"I submit on behalf of my clients that the Crown has failed to make out any case—that the only reason for the prosecution is that the Governis becoming increasingly embarrassed—indeed desperate because it can find no other way of retarding the rising tide of non-European aspirations and demands—that it imagines that if it jumps on to the anti-Communist Band Wagon it will recapture some of the reputation which it has lost amongst the nations of the world—that in its desperation it has taken these steps to prosecute the accused under an Act which although supposedly intended to suppress Communism is now being used in an endeavour to suppress the legitimate aspirations of the non-Europeans.

THE LIE

"Consistent with this attitude is the formulation of charges in which my clients are alleged to have aimed at the encouragement of race hostility or the promotion of disturbance and dis-Such allegations are recklessly and irresponsibly made, despite the evidence of those witnesses called by the Crown who throw the lie directly into the face of this Government which makes these allegations.

HYPOCRISY

The blatant and unashamed hypocrisy which is thus exposed is consistent with the mentality that says "the greater the lie the more chance of its acceptance."

Vaderland Attacks Students -Youth Congress Replies

"It appears that pressure has been applied to this appeal by pickets who were posted at the schools. No wonder that it has triumphed over the warning of the principal, that school children should neither be heard nor seen in politics, and that their places are behind desks.

CLOSE THE SCHOOL

"This is not a matter for the principal and the police, but the Department of Education, who should take the matter in their hands. Owing to its magnanimity, it has provided educational facilities for Asiatics, although it is not compelled to do so. If Asiatics spurn these privileges, then they should be withdrawn, as a beginning, shall we say, from a few of the ringleaders, or perhaps close the whole school for a week, and thereafter, for good.

"We suggest the same steps to the principals of universities, for their unruly students."
