- 1. Previous minutes: The minutes of the previous meeting were read and adopted
- 2. Report backs: The Black Sash, who initiated the call, felt that serving on such a committee would strengthen their stand, and that the depressing results of the referendum would add further impetus to the call. At their last meeting they expressed the feeling that there should be a big focus on the End Conscription Campaign.

The United Women's Organisation reported that they had discussed it at their Executive Council meeting, and that branches would send observers to the committee and that further discussion would take place in the branches. They reported that they were sympathetic to the campaign.

Che Catholic War and Peace Society reported that they had not yet been able to discuss the matter.

COSG reported that the End Conscription Campaign would be a major campaign in the organisation and that it would be taken up nationally.

NUSAS reported that they had had a preliminary discussion, and that the committee and campaign would be important for NUSAS. They reported that they were affiliated to the UDF, so this was therefore their primary point of reference and would influence the way in which they saw the campaign. They felt that the extension of conscription would be an important aspect of the campaign, and that they would need to look at ways of linking up the campuses. They also felt that the conscription issue needed to be raised creatively on campuses and within organisations in the following year, and that there was a need to convince students of the importance of the campaign. Areas that they felt needed to be looked into were the change in legislation, the

Defence Amendment Act, and the increase in militarisation.

TEAM reported that they were very interested and were completely behind the campaign, but were waiting for a lead.

ADAC reported that they had discussed the campaign at their last meeting, and as they are a resource organisation, felt that this might mean that they would not be formally represented on the committee. They felt however that they would need to maintain links, and would send observers to meetings. They felt that information arising out of their work on repression could be fed into the campaign, and felt that there was a need to link the military and repression, and cited the example of Namibia.

The Women's Movement for Peace reprted that the campaign had only been discussed by their central committee, but that they were very much behind the campaign. They felt that they could offer educational input to youth.

The representative from the Methodist Church reported that they had had a meeting of the Christian Citizenship group, and that they confirmed their continued participation in the campaign, paricularly with respect to the extension of conscription.

UCT SRC reported that they were obviously a constituent of NUSAS, but that militarisation had had a high profile on the UCT campus, and therefore, given this ground-work, the campaign could be easily taken up. They felt that the call to end conscription would play an important role on the campus in the following year.

3. Structure of Committee

It had been hoped that no discussion would be necessary, but it was felt that there was a certain amount of confusion, it would be necessary to discuss exactly what the committee would entail. The COSG anti-conscrription committee stated that they felt that the committee had never been envisaged as an organisation, but that it was rather a co-ordinating committee of organisation who wished to work in this area and who identified with the working principles. In the light of this they proposed that brief adaptations should be made to the Working Principles and to the Draft Proposals. Amendments dealing with membership, representation etc. were then made, and the amended Draft Proposal was adopted as the structure of the committee. (Please see attached copies)

4. Structure of the Executive.

The planning committee suggested that the executive should consist of one student representative, one representative from COSG, one representative from the Black Sash, and someone who could liase with the churches. An amendment

to the executive structure was proposed and adopted, this being that the executive should include four persons and not be comprised of four persons alone. The sructure and composition of the executive was then adopted by the meeting.

5. National COSG meeting.

COSG reported that there would be a meeting held in December which would be attended by representatives from COSGs in most centres. The purpose of this meeting would be to discuss the campaign, and as campaign committees in other centres were in various stages of formation, it was necessary for the COSGs to convene. It was hoped that the meeting would give clarity with respect to national co-ordination of the campaign.

Campaign planning.

The ideas for this were divided into three broad areas, and an 'input paper' on each of these areas was given. The areas were; A: the launching of the campaign, B: areas of work in the campaign and C: a pessible programme of action. It was however stressed, before the papers were given, that there was a need for flexibility in the campaign. (These papers have been typed seperately, and are included as an appendix to the minutes)

7. Discussion and general.

Arising from the papers, it was stated in discussion that media for the campaign neede to be good. Discussion also took place with respect to the timing of and the definition of a launch, and it was suggested that late: 1000 February could be a possible time for a launching of the campaign. The Black Sash stated that they had a conference in Johannesburg from the 15-18 March, and that this could possibly be useful with respect to the launching of the campaign. No decision however, was taken regarding the nature of and timing of the launch, and the meeting felt that the national COSG meeting might provide guidance. The method of taking up the campaign was discussed, and it was felt that the issue should be linked to work that organisations were already doing, but bearing in mind that it should not become isolated to one area. The need for personal contact was also stressed as an aspect of the campaign. It was suggested that working groups be formed within organisations to work specifically on this issue, depending of course on how organisations were structured. It was then said that the Justice and Reconciliation group of the Western Province Council of Churches would take up the issue in various denominations, and that this would function as a working group. The need for

resources was also stressed, and it was said that we need to preach to the unconverted.

8. Next meeting.

The date for the next-meeting was set for the 19 January 1984, and the meeting would begin promptly at 7.45 p.m. The venue would be the Rondebosch Congregational Church Hall. Included in the agenda for the next meeting, would be a further discussion of resources, a report back from the national COSG meeting, and a report back from the executive of the committee.

1. PREVIOUS MINUTES:

Minutes of previous meeting read and adopted.

2. REPORT BACKS:

(a) NUSAS

NUSAS reported back that there had been a session at their National Congress devoted to the end conscription campaign. This had been very well attended which showed the enthusiasm and interest of students in the campaign. The session raised some problems which may have to be tackled in raising the issue:

- (i) that the call is an unrealistic demand which the government cannot afford to meet and which students might find difficult to conceptualise;
- (ii) there is a deeply entrenched fear of the communist threat which may result in antagonism towards the campaign;
- (iii) the extent of government propaganda will continually undermine the rationale of the campaign.

Despite these points, the campaign was seen as having vast potential. It was felt that at UCT particularly, the campaign would be well-received since the groundwork had been layed by consistent raising of militerisation issues around conscientious objectors. Smaller campuses such as Rhodes and Pietermaritzburg would have more difficulty in taking the campaign up because of the fear of right-wing backlash, but would still attempt to take up the campaign in some way.

The campaign was definitely seen as one of NUSAS's central campaigns for 1984.

(b) December 4th Meeting of COSG Representatives in Johannesburg The meeting was attended by three Cape Town people, seven Johannesburg people, two Durban people and two Rhodes people. The discussion was inconclusive due to the very different stages of development of the regional end conscription committees:

- Jhb has no formal committee as yet;

- Dbn has formed a committee and broken into subgroups such as media and research;

- the Rhodes people merely attended out of interest - there is no ECC in the Eastern Cape as yet.

There was discussion around the launch of the campaign and three main points emerged:

(i) that an early launch was necessary;

(ii) that contact between the regional groups was very important; in this regard

- minutes must be circulated

- a meeting during the year was necessary

- COSG Conference in July could be orientated towards the End Conscription Campaign;

(iii) that the post-July period would hopefully see the emergence of tighter national co-ordination, once all the committees were established.

Following this report back, the meeting discussed ways in which more productive contact could be made. Several suggestions emerged:

(i) that use should be made of the NUSAS national structure and national gatherings which occur quarterly, to stimulate contact;

(ii) that the travelling patterns of the committee's members should

be presented at the next meeting;

(iii) that contact addresses in each area should be circulated to all members of the committee, so that people going on quick visits can take the latest minutes or other information with them.

The importance of a national structure was also emphasised. It was felt that this would help to challenge national structures (for example, church groupings) to take up this issue. To this end it was seen as essential that a common set of working principles were adopted nationally.

(c) Executive Meeting The executive met to plan for this meeting and to finalise positions, which are as follows:

- 3 -CAMPAIGN PLANNING: A scenario was presented to the group to stimulate ideas. It was felt that there was a need for flexibility in the campaign to suite: (i) the pace of the regions; (ii) the constituent organisation; (iii) and complement the UDF campaign. It was, however, seen as necessary for the Cape Town ECC to structure activity until such time as national co-ordination becomes possible. (The scenario presentation has been included as an appendix to the Minutes.) Two ideas from the scenario were taken up by the committee: (1) A Survey This it was felt would be useful to - establish general public opinion - establish the influence of government propaganda - reach large numbers of people in a non-threatening way. The committee was unsure as to whether this should be a national or regionally limited survey. It was felt that it would be difficult to use the results to accurately assess the opinion in any constituency. It was suggested that the main thrust of the survey would be to raise militarisation issues with a large number of people and to give the committee some profile. Another important result of the campaign would be the education of the people who actually carry out the survey. A group was set up to look into the feasibility of a survey, with Richard Goode as their co-ordinator. (2) Preparation Morning An idea was presented to hold a preparation day to which a minimum of five people from each organisation, and other interested parties, would be invited. This morning would serve to put a bigger range of people up to date with the progress of the campaign. The committee felt that this was very necessary at the early stages of the campaign for two main reasons: (i) to motivate organisations to take up the campaign; (ii) to give them an idea of the other organisations working on the committee. A date was suggested and accepted for the preparation morning: 3RD MARCH 1984. A group was set up to organise a preparation day, with David Schmidt as their co-ordinator. 4. During the course of the survey discussion, the question of who we were directing our campaign at was raised. After some discussion, several points emerged: (i) that there was a need for regular report backs on the progress of the UDF campaign against the extension of conscription; (ii) it was noted that COSG was represented on the UDF conscription commission; 4/

(iii) it was felt that if this committee was to merge nuder the UDF banner, it would limit church participation, since they would be unable to affiliate to an explicitly political grouping.

5. FINANCE:

Nothing was raised.

6. GENERAL:

- (1) It was noted that OBS Area Committee was holding a meeting against the Angola invasion (THURSDAY, 26 February).
- (2) There is a new book out on the Draft Resistance Movement in Vietnam called "Out Now" by Fred Halstead a participants account.

7. NEXT MEETING:

Date for the next meeting was set for the 22nd February at 8.00 pm, to be held at the Rondebosch Congregational Church.

- 1. Gerald Shaw gave a background and a perspective on the peace negotiations which are currently taking place between Angola and South Africa.
- The Secretary apologised for the typing error of "Glack Sash".
- MATTERS ARISING:
 - (a) Contact
 - (i) There was a reportback on recent contact with the Johannesburg and Durban ECCs.

 Johannesburg Group: They had their first-meeting on the 31st

January, which was attended by similar groupings to ours.
All groups contacted about the meeting were sent a dossier on militerisation, which was compiled by the COSG group dealing with end to conscription. The Johanessburg ECC has adopted the Cape Town group's working principles.

<u>Durban Group</u>: This group has had three general meetings. They have divided into four subcommittees:

(i) Research

(ii) Namibia

(iii) Media

(iv) Alternatives to War

This committee is also made up of similar groupings to our own. Both groups see themselves as co-ordinating groups as opposed to formal organisational structures.

Two ideas were discussed to enhance the national character of the campaign:

(i) Survey - generally seen as an important, feasible idea.

- (ii) Conference this idea needs discussion in all the centres. Seen as possible happening nearer the end of the year. Could be used to:
 - (a) pull the campaign together in regions;

(b) provide a show of strength;

- (c) provide an opportunity to lay plans for future of the campaign.
- * Decisions on both these ideas need to happen fairly quickly.
- (ii) There is a WPCC Conference in late March and it was mentioned that this might be a good occasion to present a paper on the ECC.
- (iii) Similarly, there is a national Black Sash Conference around that time, with a slot on militerisation. Black Sash people on the ECC saw the possibility of presenting a paper on the ECC.
- (iv) UDF Contact:

An approach has been made to WC UDF executive to discuss the relation between this committee and the UDF Commission. UDF executive felt that things were not sufficiently clear on the commission at this stage for such a meeting to take place. However, once things are clearer they will meet with the ECC to work out a parallel function.

The idea was raised and accepted that a letter should go to UDF executive inviting interested organisations or area committees to attend ECC meetings.

(b) Preparation Day

(c) Survey:

This group has met and has representatives from NUSAS, Sash and TEAM.

NUSAS - Saw the advantage of a survey with quantifiable results.

Sash - Saw survey as best being done along the lines of the nationalist propaganda techniques in the referendum.

The group has decided that with differences in thes ideas, that they will need to proceed with flexibility.

4. IDEAS FROM ORGANISATIONS:

TFAM

TEAM is considering a No War In Namibia Campaign. The aim of the campaign being to instigate action to end war in Namibia and to use this campaign to raise the issue with church groups.

COSG

- * Video idea was pointed to in the report from the COSG weekend.
- * An idea was raised to bring out a declaration around the time of the Defence White Paper and to get as many organisations and prominent people to sign it as possible. This idea was enghusiastically accepted by the committee. It was decided that a declaration should be drawn up and sent to all organisations to endorse.

5. NEWSLETTER:

The idea to have an ECC newsletter was raised. It was felt that this would be a very good way to give the ECC profile and raise the issue with constitutent and interested organisations. It was decided that organisations should bring names of people who are interested in working on such a newsletter back to the next meeting.

6. FINANCE:

It is apparent that we need money for minutes and for a newsletter and we are sure to incur ongoing expenses.

The Executive was mandated to draw up a budget.

- 2) MATTERS ARISING:
- a) Reportback- the Preparation Day was felt to have been very useful in broadening discussion about the campaign, and in bringing members of ECCorganisations together. The ideas raised in the small goups were then outlined for discussion and action, viz:

It was felt, on he question of a general survey, that the Sash survey should be the most widespread. In conducting a general survey for a rigorous definition of the target group and afollow-up to the survey were raised.

- (iii) Youth -a meeting should be arranged for groups working with youth, such as NUSAS, SUCA, and Kolbe, to discuss coordinated action.
- (iv) Media- suggestion that sub-comm of ECC be established to produce the newsletter was accepted, as was the need to draw on organisations members to do the occasional work that is required.

- (v) Church contact- discussion deferred.

(1) CORRESPONDENCE

The secretary read through correspondence from Durban COSG, noting especially that (a) Natal feels that the campaign is not strong enough to warrant a national conference. However, it was felt that a co-ordinating meeting of a small group of people from each centre would be useful. They propose a meeting following the COSG conference. (b) they are not satisfied or supportative of an "end" or "anti" type of campaign slogan. They feel that a more positive name should be adopted and that 'ECC' should not be accepted merely by default.

(2) REPORT-BACKS : BLACK SASH

Member from the Black Sash reported that the Black Sash wholeheartedly supported the campaign. A resolution to support the campaign was passed unanimously. It was noted that some Black Sash members were surprised at certain activities of the SADF mentioned at the conference, (eg. removal of children to weekend camps) and that this pointed to the necessity of internal education. Details about the survey were not available at the meeting, but ideas for the execution of survey were presented:

each member of the Black Sash would take responsibility for surveying
 5 people

 surveys would be distributed at shopping centres on a particular Saturday morning.

SACC

A meeting took place of the Justice and Reconcilliation division of the SACC. Several problems were discussed which related to militarisation and conscription not being taken up in the churches.

i) at the last SACC a resolution calling for an end to conscription was

blocked.

ii) there is a lack of clarity as to the relationship between militarisation and conscription.

iii) with the peace talks, it is difficult to work out who will now be described as the enemy by the State.

the sensitivity of the military chaplain issue is seen to be a stumbling block to the churches' participation in the end conscription campaign.

In June the SACC is going to have a conference focussing on militarisation. The programme will include Namibian speakers and plays. with a specific interest in militarisation will be encouraged to attend.

This group also discussed the Board for CO's. The acceptance by the State that the churches would participate on such Boards was questioned. Also attention was focussed on the idea of a just revolution, following on from the idea of the just war theory, and how neither of these positions are accommodated by the Board.

(3) SURVEY at UCT

The results of the UCT SRC survey were discussed. The survey which was not scientific, was highly successful in stimulating debate on campus. Altogether 1037 students answered the survey. The main results were :

Question 5 : Do you think there should be conscription into the SADF? YES: 36%; NO: 64%

Question 7 : Do you think there should be cadets/YP at school? YES: 38%; NO: 62%

Question 8 : Do you think the presence of the SADF in Namibia is justified? YES: 37%; NO: 63%

Question 9 : Do you think the SADF is politically neutral? YES: 6%; NO: 94%

Question 10: Do you think we are adequately informed about the activities of the SADF in the media? YES: 9%; NO: 91%

(4) DECLARATION

The declaration was discussed and final wording agreed upon. Two members of the committee will write out the new declaration and write out a possible list of names and organisations to get to endorse the declaration. MINUTES OF THE 14th MEETING OF THE END CONSCRIPTION COMMITTEE HELD ON 16 AUGUST 1984

PRESENT: COSG, Black Sash, SUCA, TEAM, War and Peace, Claremont UWO and UDF

APOLOGIES: Board of Social Responsibility, WPCC, Methodist Citizenship Board, Civil Rights League, UCT SRC, Observatory UDF

1. EXECUTIVE REPORT

The executive has begun its meetings with ECC organisations. So far Leslie and Mike have met with Catholic Justice and Peace. Meetings have been planned with BSR, War and Peace, WPCC and the Community Arts Project.

They also met with Archbishop Russell, who indicated that he would only be able to sign the declaration once it had been endorsed by Provincial Standing Committee or the Synod of Bishops. These groups would be meeting later in the year.

Tri-Cameral elections

Mike noted that the executive's letter concerning the extension of conscription to coloureds and indians, had been published in the Cape Herald, but not in the other 3 Cape newspapers.

Executive functions

The executive has delineated specific tasks for each executive member:-

<u>Chairperson</u> - chairing meetings, representing ECC publicly, assisting with liaison, and with international and press contact.

<u>Vice-chairperson</u> - replacing chairperson in his/her absence, financial co-ordination, liaison with lawyers and hall-booking.

Secretary - minutes, correspondence and keeping records.

<u>Liaison officer</u> - liaison with ECC and other organisations, international contact.

Media officer - co-ordinator of media committee, press liaison.

2. FINANCES

Mike stressed the urgency of this issue. ECC had no funds whatsoever. Three solutions were outlined:

- (a) the executive has written to Durban and Johannesburg ECC's requesting that we apply for funds internationally as soon as possible, rather than waiting until January to make this decision. We could easily draw up a provisional budget.
- (b) All ECC organisations have been approached to contribute between R5 and R20 per month to ECC. Organisations could decide how much they could afford. So far Black Sash is the only organisation to specify their contribution: R15 per month.
- (c) Tight financial co-ordination was stressed. This will be ensured through a small finance committee co-ordinated by Beaver. The executive has requested that someone see it as his/her comradely duty to assist Beaver. All s/he will need are limited book-keeping skills. Margot indicated that if no one else volunteered, she would be willing to assist.

3. ISSUES ARISING FROM WORKSHOP

(a) Declaration

Proposed date for launch: weekend of 13/14 October.

Proposed form: to draw in UDF anti-conscription committee as a co-sponsor; to go as public as possible and incorporate drama and cultural elements into the programme. Richard will approach ACC.

And adhoc declaration sub-committee will be formed at the next ECC meeting. All affiliates are requested to send representatives.

So far 24 organisations and 15 individuals have endorsed the declaration. The latest endorser is the National Catholic Federation of Students.

(b) Youth

It has been suggested that organisations working amongst youth meet to discuss next year's youth focus. Since no one volunteered to co-ordinate such an initial discussion, it was suggested that it be postponed. Alternatively, the COSG schools group could co-ordinate such a meeting.

(c) Namibia

The Namibian Students' Organisation is planning to hold a solidarity meeting at UWC on the 26th August (Namibia solidarity day). Richard will request that ECC be permitted to make a statement of support.

The proposal that ECC form a Namibia sub-committee was postponed for discussion until our next meeting.

(d) Media

All affiliates were requested to put forward representatives to sit on the media sub-committee. The co-ordinator will sit on the executive. Margot was nominated to co-ordinate, but a final decision was postponed till the next meeting.

4. ECC MEETINGS

The executive suggested that brief (15 minute) input on a topical issue related to conscription be provided at each meeting. However, the majority feeling was that such inputs would make our meetings too long, and would be too much of a work-load for organisations to bear. In the end it was agreed that if particularly topical issues arose, then the executive could organise a short input/discussion.

The executive also suggested that tea be re-introduced at meetings. But again the committee decided against it, the majority feeling being that after 2 hours' discussion, people weren't keen to "hang around".

5. GENERAL

SUCA requested that affiliates return money for Namibia sweat-shirts.

It was noted that Vivien McMenamin's term of office on the UCT SRC had come to an end, and that she was resigning as ECC secretary. The committee expressed deep appreciation to Viv for all her work (much of it "behind the scenes"), and for her cheerful contributions at meetings. Thanks, Viv - truly a daughter of Africa.

- 1. CORRESPONDENCE
 A letter responding to the ECC pamphlet, "What does the call-up mean to you?" was read out.
 - REPORTS

 a) International Namibia Day
 Richard reported on the meeting held at UWC, which was addressed by 2 SWAPO members. There was also poetry and a short play. A message of support from ECC was read out. Overall, the meeting was very good with a strong spirit of unity. The common theme was: "Their struggle is our struggle."
 - b) UDF Anti-Conscription Committee
 Richard reported that the ACC is going through a process
 of assessment and re-appraisal following the August 22/28
 elections.
 - Organisational activities around conscription

 Observatory UDF reported that it would be holding a workshop on September 2 at NUSAS Head Office from 5 p.m. 10 p.m.

 The workshop will include short talks on militarisation, and the psychological effects of militarisation, a video on conscription, simulated exercises about how to debate the issue of conscription, group discussion on the campaign, and a 'cultural supprt'.

Anglican BSR reported that it was trying to change the Anglican canons, so that for military chaplains to operate in any area, the permission of the resident bishop would be required. Ivan pointed out that the Bishop of Namibia has indicated that he would refuse to give such permission. The BSR is also producing a booklet on militarisation, with information on the law, the board, synod decisions, etc.

UCT SRC reported that two candidates in the SRC elections
Paula Hathorn and Donald Skinner, were standing on a
"Unite Against Conscription" ticket. In the course
of their campaign they had managed to raise the conscription

<u>Claremont UDF</u> reported that they intended running an education focus on conscription over the next few weeks.

d) Exec.Meetings with organisations

Anglican BSR - Lesley and Mike met with about 10 members of the Board and received a very positive and supportative response. They raised the possibility of having a permanent representative on the Board who would focus on conscription. They also spoke of taking up the issue formally in church structures.

Community Arts Project - They wont formally join ECC, but their facilities are available to us.

WPCC Board - Mike addressed about 30 members of the Board this evening. The board members then raised the difficulties they have had in taking up the issue in the churches. They endorsed the declaration and said that they would take it back to their denominations for endorsement.

3. MEDIA COMM.

Margo Lynn was ratified as the co-ordinator of the Media Committee. She will sit on the Executive.

4. DECLARATION LAUNCH

a) Process leading up to the launch
The following suggestions were made and discussed as to the type of activities ECC could engage in over the next six weeks:

* Teleletters and letters to newspapers.

Press Conference

PicketsPamphlets

* Cultural Road-Show

* Slide Show of the declaration

* A slide in cinemas

* A concert (there was much debate as to the value of a concert in terms of raising the issue of conscription. In the end, the majority feeling was that we should go ahead with a concert, aiming it at an audience which we don't reach through meetings, etc).

* A display

* An A.1 poster of the declaration

* A feature in the newspaper

- * Debate in the press around the Argus' lack of coverage of conscription.
- An advert in the paper with endorsees listed.

 A public debate, preferably organised by SAIRR or Civil Rights League.
- * Mass distribution of the declaration.

* A vigil.

* A day of prayer in the churches.

b) Launch
It was stressed that we must go as wide as possible, aiming particularly at conscriptees and their relatives, but also drawing in those organisations which have endorsed the declaration, but whose membership is not yet conscripted. The programme must be exciting, incorporating cultural activities and discussion from the floor.
