ORIGIN AND DLVELOPHENT OF ALEXANDRA.

EARLY CHURCHES AND SCHOOLS.

1. The Methodist Mission.

In January, 1913, some ten months after the approval by the Assistant Surveyor-General, Mr. H.E. Schoch, on the 23rd April, 1912, of the amended plan of Alexandra whereby the original 338 lots of the 1905 plan were sub-divided into 2308 lots to be sold to non-whites, there were about 40 houses and about 40 Bantu and Coloured families in the Township; which is named after queen Alexandra Mother of King George the V.

Most of the dwellings were concentrated in the north western corner of the township, the remainder spread over isolated patches to Rooth Street in the south and down to the western bank of the Jukskei Kiver in the east.

The first church erected in Alexandra, in 1912, was the Wesleyan Methodist Mission at No. 11 - 3rd Avenue, where the original wood and iron structure built by a Mr. Tladi of Benoni is still to be seen near the Skeen Bantu School. The ground on which the building stands as well as that of the present church was transferred to the Wesleyan Methodist Missionary Trust Association on the 3rd September, 1912.

There must have been a fairly substantial number of adherents in the area at the time to warrant the construction of a building to accommodate some 50 persons in a population of some two to three hundred residents.

At that time the Superintendent of the Witwatersrand Methodist Mission was the Kev. Henry walter Goodwin with Rev. Morley as his assistant and probably, because the size of the congregation was not large enough to justify the appointment of a qualified Minister, an evangelist Mr. E. Mtimkulu was put in charge of the mission.

During Mr. Mtimkulu's term of office a dayschool was started by the late Mrs. Kunene of 6-3rd Avenue.

Mr. Mtimkulu was succeeded some five years later by Evangelist S.F.M. Ntingana who was followed in turn by Evangelists J.P. Mngoma, Legodi and Gqado.

Of the resident ministers, after the last named Evangelist, the first was the Rev. S.B. Skolo, who in turn was succeeded by Revs. M.D. Maleleke, A.G. Tshabalala, A.S. Ngubeni and to the end of 1961, by Rev. D.M. Mokhele.

The church building in 2nd Avenue was erected in 1918 by Mr. Adam van Kramberg, the foundation stones being laid by Mr. H.B. Papenfus, M.L.A. and Mrs. E. Mtimkulu, wife of the first evangelist, respectively, on the 1st September, 1918.

With the development of the township and the consequent increase in population it became necessary to expand classroom accommodation, which up to 1938, was provided by the church hall

that had been extended by two additional wings.

Way back in July, 1915, Mr. B. Mqwa, son of Evangelist Mqwa of Spes Bona, took over from Mrs. Kunene as head of the then firmly established primary school. Mr. Mqwa qualified as a teached at Kilnerton Training Institution and as principal of the Alexandra Wesleyan School he had Miss Sophia Malenda (now Hrs. Chuene) as his assistant. After Mr. Mqwa there followed in turn as principals of the school, still housed in the old wood and iron building, Mrs. Dlambula, Mr. Amos Tabane and Mr. Fred Habedi. By this time the enrolment stood at about 200 pupils under Rev. Bottrill who succeeded the Rev. Goodwin as District Superintendent.

When the school was transferred to the new church building in 2nd Avenue, the principal was Mr. (later Rev.) W.B.D. Modikoane, a talented and energetic personality in whose time the A.W.S. came to be regarded as the leading educational institution in the township. Mr. Modikoane was succeeded by Mr. A.B. Moeletsi under the late Rev. Carter who had taken overfrom Rev. E. Bottwill as Superintendent. The next principal was Fr. Lerutle, then Mr. (later Rev.) D.K.W. Kambule in whose time (1938) 8 classrooms were built by Mr. Thabede with the Rev. Skolo, previously mentioned, as resident minister.

In 1940 Mr. J.D. Gamede, was appointed principal and held that position for 16 years, the longest period in the history of the school for this position to be held by the same person and on his retirement in 1956, was succeeded by Mr. S.S. Skepe-Ka-Khali, the present incumbent of the post.

Among the teachers who served in the Alexandra Methodist School as assistants since its establishment were: Messrs. Magodiela, Thibedi, Maleke (now a minister of the church), Mesdames Ngcangi, Mophosho, Kamushu (Mrs. Amos Tabane), Nkomo Fauline and Else Mayisela and E. Ncube.

At the end of 1961, the Methodist Church Membership in Alexandra stood at about 3,000 and the school enrolment at more than 560. The school now falls under the control of the local School Board in terms of the Bantu Education Act.

Of the Methodists who shared in and contributed to the Mission in particular and the township in general may be mentioned among other the following families, many of whose surviving kin are still regular pillars of the church: Molefe; Mophosho; Zuma; van Kramberg; Ngcangi, Jass; Kunene; Ranku; Mathe; Mokhele; Molete; Seatlholo; Mothibi; fetwayo; Khampepe; Maraba; Mafole; Kampa and Fassie.

All Bantu females, whether in possession of Reference Books or not must also report to the Influx Control Officer of the Feri-Urban Areas Health Board Bantu Administration Department at Wynberg to obtain documentary proof of their right, in terms of Section 10 of the Native (Urban Areas) Jonsolidation Act, No. 25 of 1945, as amended, to remain in the urban area of Alexandra.

THE EDITOR OF THE BULLETIN.

May I please have the pleasure of having freedom of expression, and extend through the Bulletin my feelings in opposition to the statement appearing in the Bulletin of November, 1961, which reads thus "To proof that experience teaches us nothing is the fact that the end of one love does not prevent us from beginning another."

I would like to draw the attention of the Bulletin readers to the following two old English maximums which reads thus (i) Experience is the best teacher. (ii) Burned child dreads the fire.

I shall start my point of argument from the latter expression - Burned child dreads the fire, and the word burned is a verb in the past tense of the word burn which really implies that the child must have experienced something very unpleasant and effective produced by fire, possibly on its finger tips and as a result the child has now experienced that fire is not a toy with which it could play and handle carelessly as the case is, particularly prior to the experience undergone and the bitter burning sustained by the child who held the fire childishly, because the poor soul lacked experience.

To start with no man can be employed or be offered a job which requires experience if he has no experience whatsoever of that type of job.

Now let us take with acute inspection what are the major causes of the end of love, possibly misbehaviour, lack of taste and many other uncontrollable complications prevalent between the two lovers because they lack experience of how to govern love harmoniously, therefore failures and faults in love eventually lead to a successful failure of love.

ORIGIN AND DEVELOPMENT OF ALEXANDRA.

EARLY CHURCHES AND SCHOOLS.

(11) THE ANGLICAN MISSION.

Diocesan work began in 1914 on one stand, 44-8th Avenue, which was given to the church by Mrs. L.M. Campbell, Secretary, and later Director, of Alexandra Township Ltd.

A building about 20 feet long by 16 feet wide of mud walls and wood and iron roof was erected to serve as a church (St. Thomas) and was placed under the care of Mr. Israel Albert Lytelton Mtshazo, an unpaid Catechist who lived at No. 60-8th Avenue, Alexandra. Mr. Mtshazo was born at St. Matthews Mission, Cape in 1879 and after working on the mines in Rhodesia, settled in Alexandra shortly before the establishment of the Alexandra Anglican Mission.

In 1915, Mr. Mtshazo started a private school which later became known as St. Thomas' Aided Mission School.

In February, 1918, the Northern and Eastern walls of the church were washed down by heavy rains which fell along the Reef and washed away the Main Reef Road at Longlaagte and other places on the West Rand. Fortunately the roof of the building did not collapse. The walls were restored - with burnt brick.

About the middle of 1918 St. Thomas School was registered with the Transvaal Education Department as a Government Aided Institution and was taken over by Mr. J.J. Musi, Teacher-Catechist as principal with Miss. Mary Ann Mkula as assistant teacher.

Mr. Mtshazo left the school shortly thereafter and on the 19th July, 1919 was appointed as a clerk, later as Sanitary Overseer and Roads Foreman by the Alexandra Health Committee, positions he retained but for two breaks in service of about 2z years each until 1948.

In 1920, the Diocesan authorities bought the vacant stand, 46-8th Avenue where the priest's house now stands. At about the same time the local Congregation extended the church by one aisle on the South side under the guidance of Mr. Pika, father of John Pika of 6th Avenue.

Mr. Musi had the first building erected at 46-8th Avenue as a Catechist's house - it was of raw bricks but a rather imposing structure in those days.

Principal J.J. Musi left Alexandra in July, 1923 to join the staff of Pimville Government School, subsequently renamed after him and now known as Musi High-School.

He was succeeded as principal by Mr. (later Rev) G.L. Nyovane who carried on in that capacity until December 1926 when he left for St. Peter's Theological College to train for the Ministry. Mr. Nyovane had previously succeeded Mr. Musi as principal of St. Luke's Mission School at Evaton in January 1920.

Mr. Nyovane was assisted (at St. Thomas) by Mr. Ezekiel Rapoo and Miss Ramphomane.

Mr. G.I. Nyovane was succeeded in January, 1927 by W.D. Nyovane who carried on until 1931 when Mr. P.E. Tsele took over the principalship of the school.

Of Mr. Musi, the Rev. G.L. Nyovane says: "He was a capable teacher and highly respected person - he was a member of the Alexandra Health Committee which was the local authority - partly with powers of a Town Council".

And of Mr. W.D. Nyovane: "He was a great organiser he placed St. Thomas School at a higher level. He was first to introduce Boys Scouts - with a band".

Rev. Nyovane goes on to say: "St. Thomas' was associated with great names such as Mr. Mothlhabi who was a D.V.T., Rev. Kobie Smith of Orlando fame; Aaron Molefe of Roodepoort; Misses Eunice Ntutu (Sister of Mrs. A.V. Moatshe Assistant Warden of Meintjes T.B. Settlement) and Irene Somgesi".

Rev. G.L. Nyovane was ordained Deacon in December, 1928 after two years training at St. Peter'. Theological School, Rosettenville and Priest on Holy Innocents Day - 28th December, 1930. He worked under Father Stephen Carter C.R. as Curate of Alexandra and became priest in charge of the Mission in 1932. He also succeeded Rev. H. Mtobi at St. Martin's Church, Sherwell Street, Doornfontein.

During his time both the church and school developed enormously. It was during his time that the Parish Church of St. Michaels and All Angels was built in 1930, the foundation stone of which was laid by Archdeacon O.W.L. Skey on St. Peter's Day of that year.

Father Stephen Carter states that this church is a copy of Canon Rose's Church, St. Patrick's Bloemfontein which was consecrated in May 1921 and since pulled down as it was in a white area and in the way of a public road.

"St. Michaels and All Angels" writes Farther Carter, "is unique on the Rand in its construction. It only cost £500 (R1000) in those days and was well built by Mr. Abraham Skosana now living at Dennilton, Central Transvaal, aged 83 (ln 1961) his wife, 81 years."

It was dedicated in March, 1932. Rev. Nyovane completed the Priest's house in November, 1938.

Rev. Nyovane began to teach in 1920. He was then fresh from school - St. John's College, Umtata. Afterwards for a short period he was employed by the Native Recruiting Corporation at Germiston and as a shop assistant. It was from here that he was sent to College by Father Francis Hill to train as a Catechist. After a year's training he was appointed Teacher - Catechist at St. Thomas, Alexandra Township. He started as a teacher - catechist and finished as priest in charge. To achieve this

Reverend Nyovane laboured for 15 years. He also served as a member of the Alexandra Health Committee in 1935. He was the first in the Transvaal to obtain a Diploma in Theology. His name in this mission field is linked up with those of his Church Wardens especially Walter Neube and Hezekiel Maluleke.

Rev. Nyovane's first wife died in 1932. He married Miss. Mthombeni in 1936 and are now settled in Stellenbosch in the Cape.

REV. H. MTOBI.

Rev. Mtobi, whom Rev. Nyovane succeeded as priest in charge of St. Martin's Sherwell Street. Doornfontein, Johannesburg was a very interesting personality. He worked for a number of years as a missionary in Mashonaland and converted a great number of people. One of his parishioners was Bernard Miseki, whose marriage he solemnised on the 7th March, 1896. Less than four months after his marriage i.e. 18th June, 1896, Mizeki was martyred. His wife lived on another 50 years at Rusape, Southern Rhodesia, with the martyr's child. She (Mrs. Mizeki) was given away at her marriage by a white farmer, which shows that she did not belong to the tribal set-up.

On his return from Mashonaland Rev. Mtobi served first at Germiston then at Doornfontein where after his retirement in 1925, he passed away.

Rev. Farther Stephen Carter C.R. was Superintendent of the Mission School from 1921 to 1947; succeeded by Lieut Colonel Brown in October, 1947 and after him Tom Bishop and finally, Father Shrand until Bantu Education started in April, 1955.

Between 1932 -1947 some ten classrooms were built on the stand at 44-8th Avenue. These now house the Thabison Family Centre.

In 1945 the Catechists house - on the church ground was completed.

The last principal of St. Michaels Mission School was Mr. O.N. Phahle who is now head of the Pholosho Community School, founded in April 1955 after the Mission School was closed down.

Dr. Alfred Bitini Xuma, B.Sc. M.D., L.R.C.P. & S. (Edin) L.R.F.P. & S. (Glas). D.F.H. (Lond) Part-time Medical Officer of Health for Alexandra from November 1929 to the end of January, 1958 and thereafter under the Peri Urban Areas Health Board until 30th September, 1960, passed away at his home at Mtipa Street, Dube on the 27th January, 1962.

His funeral on the 1st February 1962 was attended by a representative number of leading Alexandra residents, former members of the Alexandra Health Committee including its one time Chairman C.J. Johnson Esq. and officials of local public bodies and institutions.

During his long term of office as M.O.H., Dr. Xuma served Alexandra's community conscientiously and efficiently not only in matters of public health but in virtually all spheres of social activities.

He enjoyed as M.O.H., the distinction of being the only member of his race to hold that position in South Africa.

In 1929 when he assumed office there were no non-white Health Inspectors in South Africa. Dr. Xuma, with Dr. Anning, sponsored the training of Alexandra's first Health Assistants namely H.K. Thipe and E.I. Nyamende, the latter being the first Non white to pass the examination of the Royal Sanitary Institute for Health Inspectors, in South Africa, in 1936.

Under Dr. Xuma also served South Africa's first nonwhite Chief Health Inspector Mr. T.S. Masekela.

Of the scores of non-white Health Inspectors in the country today, more than three quarters served and/or trained under Dr. Xuma including Mr. A.M. Dhlamini, B.Sc. the first and only non-white Health Inspector to be granted Membership of the Royal Sanitary Institute.

Dr. Xuma shared in the great work of setting up the Alexandra Health Centre and University Clinic and served as a member of its Board of Management from the time of its inception until 1958.

He was instrumental in the formation of the Alexandra Anti Tuberculosis Association first organised by Chief Health Inspector Rex Meintjes and welfare official B.O. Sibeko under the Chairmanship of Mr. S.J. Mathebula in 1949.

One of Dr. Xuma's last public functions in Alexandra was the receiving, on behalf of the residents, of the magnificent Alexandra Stadium from the Bantu Sports Trust in December 1956.

The Bulletin, on behalf of its readers and the residents of Alexandra, extends deepest sympathy and condolences to Mrs. Xuma and family.

A FEATHER IN OUR CAP.

We reproduce hereunder a letter from one of our eldest readers, Rev. S.M. Shuenyane, of the A.M.E.Church at Tembisa, which needs no comment on our part except our expression of appreciation and thanks to the writer.

"Sir,

I am writing to thank you very much for the Alexandra News Bulletin sent to me regularly eversince you started with it. Words fail to express my feelings and gratitude. To me this is more than a news Bulletin for it carries legal information and it is very educative and ever since I have been receiving it I feel myself well.informed and happy concerning the law governing the African People in the Urban Areas. I wish all my fellow ministers to read this Bulletin so that they may be able to help our people. Sir, may I congratulate the Peri-Urban Areas Health Board for its administration of Alexandra Township. Ever since the Board took over we cannot close our eyes to the many improvements done everywhere and with everything in the Township, and it is surprising as to how you people could have done all this within a short space of time".



EARLY CHURCHES AND SCHOOLS.

V. THE LUTHERAN MISSION.

In the year 1915, a branch of the Lutheran Mission Church was opened at Alexandra under the leadership of Mr. Hiskia Moatse, aided by Mr. William Maloka of the Hermansburg Mission Church. A small mud-brick building was erected in Mr. Moatse's yard at 68 - 4th Avenue for the local congregation which was regularly visited by the Rev. M. Kuschke of the Johannesburg Lutheran Mission and the Rev. William Koko.

The Church elders at that time were Messrs. David Mokoa, Joel Dibetso and Timotheus Mogashoa, the latter twc since deceased.

By 1922 the congregation had so increased that a new and bigger church building became urgently necessary. A site was acquired at 89 - 3rd Avenue where the present church, erected by Mr. M. Pretorius assisted by Dr. H. Lodewick and other members was put up.

The first resident minister was the Rev. Jeremiah Makuse who served from 1929 to 1930. The parsonage was built during his term of office.

Rev. Makuse was succeeded by Rev. E. Sehlogo who in turn was followed by the Rev. S. Makobe in 1930, who is still holding that position, with the late Rev. M. Jaeckel as Mission Superintendent.

Works undertaken.

Where the present church building stands there was a beautiful little church, the only fly in the ointment was a scarcity of water. It was agreed upon that a well be dug. Money was collected, a digger was engaged and he was paid R25.20. The water was first used to plaster the parsonage as it was built of raw bricks. It still stands to this day. The person engaged to plaster the parsonage was the late Mr. S. Mamadi. The builders of the parsonage were Messrs. Malepane and Masela.

In 1932 it was agreed upon to extend the church building. Funds were collected and 40,000 bricks were made of mud, coke and sand by Messrs. Sello and Nyathela and fired by Mr. P. Mogale. Rev. Makobe and Mr. D. Makoa were in charge of the water supply side of the project. In 1933 the Rev. M. Jaeckel requested a certain German consultant to draw a plan for the new church building. This having been done, work begun on the new building. Mr. Ranku put up the back portion and Mr. Smith the front part.

The corner-stone was laid by Rev. Hermann of the Johannesburg European Congregation. The Very Rev. Superintendent Hoffmann inaugurated the church on the 9th September, 1934.

The church building was also used for school purposes. The headmaster was Mr. Fanuel Sikoane at the time, who later became a minister of the church. His assistants were Messrs. Cecil Ndzondza and Michael Rabotho.

With the increase in the school enrolment the congregation bought an adjoining stand in 1938 from Mr. Windvogel on which a school building, erected with bricks bought from a building then being demolished, was erected. Rev. Makobe paid R80 for the bricks with funds collected by the congregation. At this juncture Rev. Jaeckel was transferred to Pietersburg and Rev. G. Westphal took over. The building of the school was undertaken by Mr. Malomba, the corner stone was erected by the Director of the Berlin Mission Church on his way from a conference in India and was unveiled by Mr. Kreft, the Director of Education. Subsequently the school was extended by Messrs. D. Lesolang and Thoele. The newly built classrooms were inaugurated by Rev. S.M. Makobe. Principals who served in this school were Messrs. F. Sikoane, M. Rabotho, K.M.E. Ramokgopa and D.P. Rabotho, the present incumbent.

The Rev. Makobe is still in charge of the Mission.

VI. THE AFRICAN METHODIST EPISCOPAL CHURCH.

The first A.M.E. Church building was sited at 49 - 3rd Avenue, the foundation stone of which was laid by Rev. C. Demas on the 8th July, 1917. The congregation at that time consisted mainly of coloured members.

The site of the present church at 46 - 10th Avenue was acquired from the late Mr. Papenfus and Mr. Campbell in 1916 by the late Rev. Nojekwa and Mr. Semenya.

From 1916 to 1923 the Africans held their services in Mr. Semenya's house.

In 1923, the late Rev. Mokau, with the help of the congregation, built a kimberley brick structure which could accommodate at least 100 members. The membership gradually increased and so in 1926 the little building was enlarged by a corrugated iron portion at the back.

In 1930 Messrs. Letle, Moeng and Draiers started digging the basement of the church which was opened by the late Dr. Xuma the same year and called Xuma's Hall. The services were then held in the basement and the kimberley brick-corrugated iron building demolished.

Late in 1930 the late Rev. B.M. Sechaba, then resident minister, and Mrs. Sechaba with the help of their congregation started the present church building. Members willingly helped with whatever they had.

These ladies helped to fetch water from the Jukskei River for making bricks as water was a major problem of the Township during those days:

Mesdames F. Motaung, M. Makhene, Rumo, B. Fume, Mogari, S. Msimanga, D. Masienyane, E. Maluleka.

Great difficulties were encountered during the building of this church.

In 1934 the difficulties were nearly over and Bishop Sims laid the foundation stone - the church was thus named Sims Tabernacle. Two years later the building was completed and was opened by Bishop R.R. Wright.

Some time during 1934 the church established a private school and although faced with the obligation of raising funds for the church building still managed to pay the salaries of the teaching staff whose pioneers were Messrs. Pelei, Langa, Nthobo, Phooko and Mrs. Mathule.

The school grew steadily and in 1936, the late Mr. E. Noge consulted Revs. B.N. Sechaba and P.M. Mabiletsa, the latter having already managed to have his private school registered, with a view to joining the two schools. The arrangement was eventually carried out with the support of Inspector Liebenberg towards the end of 1936 and the school became known as the Amalgamated School. It was joined in 1937 by pupils from the Bantu Methodist Church and in 1938 by pupils from the Christian Apostolic Church, under Rev. Ndlovu.

The Amalgamated School developed so rapidly that it was eventually divided into junior and senior sections which gave birth to the Alexandra Secondary School - a lasting tribute to the foresight and initiative of the late Principal Noge and Revs. Mabiletsa and Sechaba.

Following is a list of A.M.E. Ministers who served in Alexandra.

Rev. Nojekwa (1915 - 1916) who came every Sunday from Johannesburg to hold services. Rev. Abrams (1917 - 1918) Rev. Thomas Mokau (1925 - 1928) Rev. B.M. Sechaba (1929 - 1945) Rev. Maaroganye (1946 - 1954) who built the present Mission house. Rev. Fantsi (1955 - 1957) Rev. F.E. Tekane (1958 - 1961) Rev. J. Wesinyane.

From 1919 to 1924 Church services were held by Messrs. Semenya, Makhene and Motaung. 4/.....

ORIGIN AND DEVELOPMENT OF ALLXANDRA 1912 - 1962 EARLY CHURCHES AND SCHOOLS

IV. THE CATHCLIC MISSION.

The earliest references to Catholic activities in Alexandra Township are baptisms that were administered by Father F.X. Goodfriend, O.M.I. from the Native Mission, Sherwell Street, Doornfontein, in 1915-1916.

However, the effort to found a Mission in Alexandra came from Fretoria, frequent visits being made by Father C. de Hovre, O.M.I. in 1918, who used to cycle the distance of over thirty miles.

Some months later the Township Company donated a site at a short distance from the Main Road, i.e. at the corner of 2nd avenue and Selborne Street, and a church was built.

On the 24th August, 1918, Bishop C. Cox, O.M.I., accompanied by Faters Laurent and Roux, O.M.I., blessed and opened the new building under the patronage of Saints Phillip and James.

Father de Hovre had gathered around him in Pretoria a small group of dedicated women to help him in his various Missionary endeavours and three of them began a small school at Alexandra in a simple and small house built opposite the church.

Fhe Holy Cross sisters who began their first Mission school in the Transvaal at Bantule, Pretoria, undertook the school at Alexandra in 1920 and have remained in charge ever since; the small school today having grown to over a thousand pupils in the Primary, Secondary, Industrial and High Schools with a Boarding department for some eighty girls.

In the years between 1919 and 1927, Father E. Laurent, C.M.I., who used to travel backwards and forwards from the Good Shepherd Home at Orchards to attend to the spiritual needs of the Mission on his old "Sunbeam" motor cycle, was a familiar sight everywhere.

The first resident priest was Father H. v. Hommerich, -O.M.I., who arrived in the Transvaal from Belgium in 1926.

On February 2nd, 1930, Bishop D. O'Leary, O.M.I., laid and blessed the foundation of the present large church at the corner of 1st Avenue and Selborne Street and it would appear that it was about this time that the patronage of the Mission was changed to Saint Hubert - as a tribute also to Father Hubert von Hommerich, C.M.I.

In 1934, Father de la Jod, O.M.I., took charge of the Mission and nine years later he was succeeded by Father C. Bouffard, O. .I. In March, 1949, Father G. Coleman O.M.I.

Edite Conc

took charge and it was in the subsequent years that the Presbytery was enlarged.

hen Father Coleman was transferred to Moroka in 1961, Father de la Jod took charge of the Mission for a few months pending the arrival from Kimberley of the present priest in charge, Father J.J. Boyce, O. .I.

Associated with the early days of the Alexandra Catholic Mission, were wuch well-known personalities as the late E.P. Mart Zulu, who took a leading and active part in local affairs having served for many years as a member of the Alexandra Health Committee to which body he was elected in 1917. Mr. Zulu owned the first general dealer's business in Alexandra, the shop from which the business was carried on having been situated on the site of the present N.G. church pastorie.

Others were the Kamohanoe, Thekiso Mokae, Mkize, Msimang, Moah, Noah, Pleine, Kgope, Mbatha, Gumede, Phalatse Pienaar and Smith families to mention but a few.

Mrs. C. Ntutu served for many years as a teacher on the staff of the Mission school, from its inception. Later followed, as the institution grew bigger, Sealemetse, T. dan Napo, Jonathan Ntingana, who among tens of other teachers will be remembered by former pupils including P.M. Mabiletsa B.Sc., U.E.D., Alexandra's first University graduate.

Another Hely Cross student, Florina Msimang, joined the Holy Cross Congregation of Sisters in 1935 and is now serving in Basutoland as a teaching sister.

Four years ago, Miss Joyce Gamede, youn er sister of Nigelia, until recently on the staff of the Board's elfare Department, choose the religious vocation. She is now Sister Maria Theresa Philomena of the Dominican Sisters of mast London.

Mr. H.A. Mbatha, a former pupil of the Holy Cross School has for the past twenty years been chairman of the Catholic African Savings Union, an undertaking controlling more than R80,000 of savings and other funds.

R.T. Asimang, B.Com., brother of Sister Florina, has been General Secretary of the C.A.J.U. since its establishment twenty five years ago.

Hundreds of former Holy Cross School pupils are playing their part in the life of the non-white, both locally and throughout the land as traders, teachers, nurses, clerks, bank officials, etc.

Latest Holy Cross achievement was when one of its students, Alexandra - born Christian Phetla, O.M.I., was ordained to the Priesthood by Bishop Hugh Boyle D.D. in St. Hubert's Church Alexandra on the 11th December, 1960.

Father Peter Butlelezi, O M.I., B.A., L.Ph., is on the staff of St. Augustine's Seminary, Basutoland, whilst Miss Pauline Mkalipi, lately on the teaching staff of the High School is reading for a degree in Social Science at Milan University in Italy.

In the sphere of public health, the Holy Rosary Sisters have undertaken the nursing services at the Alexandra Health Centre as also at the Edenvale Hospital where they have been doing good work for a number of years.

Up to the end of 1960 there were more than 7,000 Catholics in Alexandra. Since then many have left for Diepkloof under the re settlement scheme now in progress.

Bantu who have to enter Alexandra for purposes of visiting are reminded that visiting permits are obtainable at the ynberg offices of the Board's Bantu Administration Department, 234 - 3rd Street at all hours every day of the week including Sundays and holidays.

The offices are not far from the Futco lynberg Depot bus stop.

INFLUX PERMITS.

As previously mentioned in the Bulletin, Influx Permits for Alexandra are granted to all bona fide applicants who report for same at the Board's Tynberg offices.

Such permits are never refused to qualified applicants and no persons may be charged or prosecuted at the Board's offices when they report for reference book endorsements. Only in cases where gross irregularities are detected, as in the case of foreign Bantu, may action be taken and even then only after exhaustive investigation by senior officials of the Department of the Board's Bantu Administration staff.

DOMESTIC S RVICE VACANCIES.

A number of vacancies for domestic servants in the North Johannesburg proclaimed area, that is, the suburban area near and around Alexandra, are at present available for Bantu female work seekers and must be filled as soon as possible.

R.G. SENDING, ALEXANDRA.

Since the last issue of the Bulletin, the following omissions in the article on the N.G. Sending, lexandra, have been brought to the compiler's notice -

> That the original Kimberley brick-wall, woodand-iron roof church was demolished when the new church, since enlarged and renovated, was erected twelve years later. The foundation stone of the present church referred to above was laid by Dr. William Nicol, afterwards Administrator of the Transvaal, on the 10th December, 1932.

The foundation stone of the 18th avenue church was laid on the 14th October, 1951.

Of the original founder members only Oom Daan Mofolo and rs. argaret odise survive.

Oom Piet Badenhorst was Station Commander, Nynberg (Now Bramley) Police Station from January 1942 until December 1953.

MNA. J.M. MAKHOTHE.

On the 23rd April, 1962, the Township of Alexandra completed 50 years of its existence as a non-white residential area and accordingly, the Bulletin gives here the story of the only living person intimately connected with the early days of Alexandra, namely Mr. J.M. Makhothe.

Jesse Jahabuke Makhothe was born in the Mafeteng District of Basutoland on the 10th of August, 1877. He received his initial education at the Matelili Training School, Basotoland, then he went to Lovedale where he passed the School Elementary Examination (now defunct) and School Higher Examination (now J.C.) and in 1903 sat for the Matriculation Lyamination in Johannesburg where he was the only African amongst 150 European candidates.

In 1899 he was Sesotho Editor of a newspaper called "Izwe la Bantu" at Last London. Thence he came to Johannesburg via Fourteen Streams; there was no railway connection between Fourteen Streams and Johannesburg at the time. In Johannesburg he worked as Tramming Contractor at Geldenhuis and Robinson Deep Gold Mines and also at Robinson, Randfontein. In 1903 Mr. Makhothe founded the Transvaal Native Congress and was its General Secretary for seven years. He did a great deal of travelling throughout the Province on the organisation's business.

In 1911 he was employed by the Alonzo Medicine Company, Johannesburg, where he worked from 9 a.m. to 12 noon daily and from 2 p.m. to 5 p.m. as Lditor of "Molomo Wa Batho". It was during this time that Mr. Makhothe was approached by a Mr. Kessel and offered the Agency to sell Alexandra lots to non-whites. Mr. Makhothe accepted the appointment provisionally, but it was not until he met the late Advocate H.B. Papenfus M.L.A., then Director of the Township Company that matters wore finalised and Mr. Makhothe began to perform the function cf property salesman.

He records that in 1912 Alexandra was just a farm, the southern portion being utilised by Italian Market Gardeners. There were also three farmhouses of which one still remains.

With the coming of the first buyers who settled in the Township, a Village Association was set up with Mr. Alex Fortuin as Chairman and Mr. Makhothe as Secretary. This Village Association was the forerunner of the Alexandra Health Committee constituted in terms of Administrator's Proclamation No. 56 dated 18th November, 1916.

The first members of the Alexandra Health Committee were

Herbert Boshoff Papenfus Christian Frederick Wienand Ernest Powys Adams Jesse Mahabuke Makhothe and Canral Cacelhaus,

the first two members representing the Township company; the third representing the Department of Native Affairs and the last two representing the African and Coloured residents respectively with Mrs. L.M. Campbell as Secretary. Mr. Makhothe resigned his membership on the Committee and succeeded Mrs. Campbell as Secretary. He held the position until 1926 and was in turn succeeded by James Ntsala, I. Bud Mbelle and others.

Mr. Makhothe left Alexandra in 1926 to settle on his farm in the Rustenburg District where he has lived ever since.

Of the Townships early enterprises, Mr. Makhothe recalls the final successful passenger transport service. This was operated by Mr. J. Modise with a horse-bus service plying once a day between Johannesburg and Alexandra. The "fleet" was later increased to two busses and consequently two trips were possible between the termini mentioned every day, morning and afternoon.

An earlier attempt to run a motor bus service had failed and so the Company at Mr. Makhothe's suggestion, acquired a horse-bus with the said J.M. Modise as a driver-conductor and later owner-driver.

Of the churches he mentions the esleyan Methodist as the first and the Anglican as the second to be established in Alexandra.

Mr. Makhothe is now 84 years of age, but is still capable of writing interestingly in a firm and clear handwriting.

ALEXANDRA LIQUOR SUPPLY UNDERTAKING.

Readers of the Bulletin are no doubt aware of the fact that the Liquor Act of 1928 has recently been amended to enable authorised dealers to sell European liquor to Non-Whites as from 15th August, 1962.

The Alexandra Local Area Committee of the Peri-Urban Areas Health Board has, in accordance with the provisions of the Act and the relevant regulations, in terms of which local authorities are empowered to sell liquor to Non-Whites, also been granted the necessary special authority and Bantu residents will be able to buy liquor from local sales points presently under construction at 99-7th Avenue and 107-16th Avenue, Alexandra.

As these sales points owing to unforeseen circumstances, will not be ready for business by that date, arrangements have been made for Bantu residents to purchase their supplies for the time being, from the converted Milk Depot at 95-2nd Avenue as from Wednesday 15th August, 1962, until further notice.

SALES OF LIQUOR AT THE CONVERTED MILK DEPOT PREMISES:

As from the 15th August, 1962 all Bantu males and females over the age of 18 years may buy liquor at the above premises on bottle store basis for <u>home consumption</u>.

There will be no consumption of liquor on the aforementioned premises.

TYPES OF LIQUOR ON SALE.

At the above converted premises all available brands of spirits, wine and malts will be sold.

> SPIRITS: will be sold in quarter bottles (nips) up to and including double bottles (quarts).

WINES: will be sold in half bottles to one gallon jars.

BEER (not Bantu Beer) will be sold in 12oz. cans and in 12oz. 16oz. and 32oz. bottles.

DAYS AND HOURS OF SALE.

As this will be a bottle store facility liquor can only be sold:

Mondays - Fridays : 10 am. to 7 pm. Saturdays : 10 am. to 2 pm. However these facilities will not be open on Sundays, Public Holidays and all election days.

QUANTITY OF LIQUOR THAT MAY BE PURCHASED:

Not less than one half pint bottle/container or more than 12 quart bottles/containers i.e. three gallons may be purchased at the abovementioned sales point by any one person at any one time.

WHO MAY BUY AND CONSUME EUROPEAN LIQUOR AT THE SALES POINTS UNDER CONSTRUCTION:

All Bantu males and females over the age of 18 years may -

- (a) buy liquor at such sales points(bottle stores) for home consumption.
- (b) use the lounges for consumption of liquor on the such premises.

Bantu females over the age of 18 years who wish to avail themselves of such lounge facilities must be accompanied by Bantu males of the prescribed age. Permission to enter the lounges for on-consumption purposes will be refused to Bantu women who are not so accompanied.

Bar facilities will be available only for Bantu men over 18 years of age.

TYPES OF LIQUOR TO BE MADE AVAILABLE.

(a) OFF-SALES:

All available brands of spirits, wines and malts. <u>SFIRITS</u> will be sold in $\frac{1}{4}$ bottles (nips) up to and including double bottles (quarts).

<u>WINES</u> will be sold in $\frac{1}{2}$ bottles to 1 gallon jars. BEERS will be sold in

> (i) 12oz. cans. (ii) 12oz. 16oz. and 32oz bottles

(b) ON-CONSUMPTION: (in bars and lounges).

All available brands of spirits, wines and malts as well as minerals or aerated waters. <u>SPIRITS AND WINES</u> will be sold in tot measures and <u>MALTS</u> in bottles or cans. <u>BANTU BEER</u> will also be sold in 10 cent measures (± 4 pints).

DAYS AND HOURS OF SALE.

(a) OFF-SALES: (i.e. Bottle Store Facilities).

Mondays - Fridays : 10 am. to 7 pm. Saturdays : 10 am. to 2 pm.

Off-consumption facilities will not be available on Sundays, Fublic Holidays and all Election Days.

(b) ON-CONSUMPTION: (i.e. Bar and Bar Lounge Services).

Mondays - Saturdays : 10 am. to 8 pm.

On-Consumption fabilities will not be available on "closed" days i.e. Sundays, Christmas Day, Good Friday, Ascension Day, Day of the convenant and all Election days.

N.B. No Liquor shall be brought into Cn-Consumption Rooms from outside or taken out therefrom for consumption elsewhere.

QUANTITIES OF LIQUOR THAT MAY BE PURCHASED.

(a) ON-CONSUMPTION.

Not more than can reasonably be consumed on the premises by the person concerned.

(b) OFF-CONSUMPTION:

Not less than one halfpint bottle/container or more than 12 quart bottles/containers, i.e. 3 gallons may be purchased at the abovementioned sales points by any one person at any one time.

VICTUALS.

There will be cafeterias at each of the liquor sales points where food will be supplied by Non-white restaurant Keepers who will lease such cafeteria from the Board.

LIQUOR SALES POINTS CAFETERIA.

Applications are invited from bona-fide and duly qualified Alexandra residents for the lease of Cafeteria Premizes from the Board at the new Liquor sales points situated at 99-7th Avenue and 107-16th Avenue Alexandra.

Applications must be directed to the Chief Brewer, Peri-Urban Areas Health Board, 234-3rd Street, Wynberg Johannesburg, on or before the 31st August, 1962.

ASSISTANTS AND WINE STEWARDS.

Applications are invited from suitably qualified Alexandra residents for the positions of Barman, Depot Assistants and Wine Stewards for the Alexandra Liquor Sales Undertaking at 99-7th Avenue and 107-16th Avenue.

Applications must be submitted on the prescribed forms and should reach the Chief Brewer, Peri-Urban Areas Health Board 234-3rd Street, Wynberg or P.O. Box 101, Bramley, Johannesburg, not later than 12 noon on Wednesday 31st August, 1962.

ACCOMODATION OF TENANTS.

The attention of property owners and landlords of Alexandra is hereby directed to the provisions of Section 27 (1) (d) of the Native Resettlement Act No. 19 of 1954 in terms of which they are required to render returns to the Native Resettlement Board, c/o 234-3rd Street, Wynberg, Johannesburg of all tenants accommodated on their properties, with effect from Monday 6th August, 1962.

As Alexandra is a <u>Specified area</u> in terms of the Natives Resettlement Act (vide Alexandra News Bulletin, August 1960) failure to comply with the requirements of Section 27 (1) (d) (or any other applicable Section of the Act) is an offence punishable by a maximum fine of RLOO or imprisonment for a period not exceeding six months.

The prescribed forms will shortly be delivered to all properties in the Township and must be attended to within the period set out in the notice.

Landlords will also note that the Secretary of the Natives Resettlement Board must be notified within 7 (seven) days if any of the tenants or occupiers vacate their rooms or new tenants or occupiers move into any of the rooms (after the 6th August, 1962).

STADIUM FLOODLIGHTS.

The new floodlights installed at the Sports Stadium, No. 2 Square, Alexandra, were "switched-on" on Wednesday 2nd August 1962, whereby residents in general and sportsfans in particular were afforded another welcome recreational amenity.



PHOLOSHO H.P. SCHOOL OFFICIAL OPENING 21ST SEPTEMBER 1962.

The official opening of Pholosho Community School on Friday 21st September was a hilarious affair. More than 600 people attended the function. Residents local and Bantu Education Officials, school teachers, social workers and pupils enjoyed the gathering which was one of the largest seen in the Township for years.

Mr. D.A.M. Prozesky, Regional Director of Bantu Education (Southern Transvaal) in his speech said - "We have come to witness this function with all our best wishes. This is a fountain of knowledge of which the pupils will be proud to make use, as well as the whole community." Other important speakers were Mr. J.H. van Dyk, Secretary of Bantu Education, Mr. J.H. Swart (Administrative Assistant, Alexandra) who deputised for the Chairman of the Board, Mr. Muller. Mr. N. T. Mgogodlo deputising for Mr. A.H.J. Els, Bantu Affairs Commissioner, read a speech from Mr. Els. Mr. Els said, "The winds of change are blowing stronger than ever. There exists today a competition in the world among nations. It is a question of who will be the first to land a man on the moon. But among the Bantu youth there is strong competition for work. It is only the educated who will get the best job. It is then important for youth to make use of this opportunity."

The high-light of the day came as Mr. Bosman, Bantu Education Supervisor, said humorously "I have patiently been listening to speeches. It is now my chance to act. If you are not strong you have to be clever. I now officially open this school." he said as he unlocked the door.

Music was rendered by the Alexandra Secondary School Choir, Pholosho and the C. Weiler Community School Choir.

Mr. D.A.M. Prozesky was presented with a walking stick by the Pholosho School Committee. Mrs. Bosman and Mrs. Modise, wives of the School Supervisor and School Board Chairman respectively, were each presented with a boquet of flowers. Mr. S.S. Modise was Master of Ceremony.

Smuts, the District-Commandant Lt.Col. de Villiers, the Regional Director of Bantu Education, Mr. D.A.M. Prozesky, the Circuit Inspector Mr. A.S. Bosman, with Sub-Inspector S.P. Kwakwa and Supervisor Nkosi in attendance.

MR. R.G. BALOYI.

The death occurred at his residence "Tsoelopele", 59-2nd Avenue Alexandra, on the 4th October, 1962, of Mr. R.G. Baloyi.

"R.G." as he was popularly known arrived in Alexandra during the early twenties where he lived until his death. He owned a number of properties in the Township and was one of its most prominent residents for many years.

He was proprietor of the famous Richard's Bus Service for many years before the advent of Putco and undertook the construction of the old Clinic building now housing the Alexandra Offices of the Peri-Urban Areas Health Bcard in 2nd Avenue.

Alexandra's first house telephone connection was effected in Baloyi's former home in 3rd Avenue. His was also the first double-storey residence in Alexandra. Mr. Baloyi, together with the late Messrs. R.V. Selope Thema and P.M. Mapikela were the first to represent the Transvaal and O.F.S. constituency in the Natives Representative Council from 1937 to 1942.

With Dr. J.S. Moroka he donated the Moroka-Baloyi Trophy competed for over many years by provincial sides of the S. African Football Association of which he was Treasurer for some time. His keen interest in the promotion of soccer led to his appointment as Hon. Treasurer of both the Transvaal and the Alexandra Football Associations, during the thirties and early forties. He was a member of the Alexandra Health Committee from 1937 to 1939. A foundation member and connexional Treasurer of the Bantu Methodist Church; former President of the Bantu Sports Club, Managing Director and Director of several public bus companies at one time and also served on many other organisations.

He was appointed member of the Alexandra School Board when it was established in 1956 and was its Chairman during the years 1958 and 1959.

At the time of his death he was attached to the Staff of Putco which he joined in 1957.

The Bulletin extends its deepest sympathy to Mrs. Baloyi and members of the family.

INDEPENDANT CONTRACTORS.

(TOGT OR DAILY LABOURERS)

The attention of Alexandra holders of Daily Labourer Permits is hereby drawn to the conditions whereby such permits may be issued and held in terms of Government Notice Nc. 1032 dated 1st May, 1949, as amended by Government Notices 3023 of 1951, 2860 of 1952 and 328 of 1954.

Regulation 12(1) provides that - "Every male Native other than a Native who is exempt from the provisions of Chapter II of these regulations in terms of sub-regulation (1) of Regulation (2) who desires to work as a togt or casual labourer or to carry on any work as an independant contractor in the proclaimed area (<u>Alexandra is a Proclaimed Area</u>) shall before commencing such work apply to the registering officer for a permit authorising him to do so, and the registering officer may <u>IN HIS DISCRETION</u> furnish such Native with a permit, substantially in the form (prescribed). The period of validity of such permit shall be for the period stated therein: <u>Provided that such period shall not extend beyond</u> the end of the month in which such permit is issued; and provided further that the registering officer may in his discretion on application by the holder of any such permit made within seven days after its expiry renew it from time to time for a period not exceeding one month.

(2) Ever Native to whom a permit is issued in terms of sub-regulation (1) shall pay to the registering officer the relative fee prescribed Provided that if the first issue of such permit is made after the fifteenth day of the month there shall be payable for that permit one half of the said fees. The fee shall be paid at the time of the issue of the permit or of any renewal thereof.

(8) Whenever the registering Officer is satisfied that a. Native to whom a permit as a togt or casual labourer or as an independent contractor has been issued as hereinbefore provided is no longer a fit and proper person to hold such permit or is no longer pursuing the occupation in respect of which the permit was issued to him, he may decline to renew such permit and such Native shall thereupon become subject to the provisions of Regulation 3 in the same manner as a native who enters the proclaimed area".

From the foregoing it will be seen:

- a) that the issuing of permits and the holding thereof is subject to the discretion of the registering officer only.
- b) that such permits are valid only in the proclaimed area.
- c) that such permits are valid for one month only.
- d) that application to renew such permits must be made within seven days after expiry, that is, within the first seven days of the month next following the date of expiry.
- e) that the prescribed fee of two shillings per month is paid at the time of applying for such renewal.
- f) that the registering officer may renew or refuse to renew such permit at his discretion.

Note expecially the underlined passages of the regulations quoted.

QUESTIONABLE INTERVIEWS AND CONSULTATIONS.

Readers of the Bulletin as well as others concerned are warned against the undesirable and grossly irregular practice of visiting Bantu members of the Board's staff at their homes in connection with matters relating to permits, endorsements, reference books etc.

Such matters are dealth with at the Board's Offices during the usual office hours from Mondays to Fridays - excluding public holidays.

Visiting members of the starf at their homes on official matters is embarrassing and annoying for the official concerned and has under certain circumstances resulted in serious complications for both the person involved and the official.

If your "problem" is reasonable and honest there is no reason why it cannot be solved at the offices.

"Interviews and consultations" with members of the staff, away from the offices, are often questionable and should, as far as possible, be avoided.

DAILY LABOURERS.

If you don't want to lose your concessions (permits) pay the prescribed fees regularly every month, preferably before the 7th.

This is a condition laid down by law and if you fail to comply then you have only yourself to blame for the consequences of your negligence.

Your Daily Labourer's permit is valid for _ Alexandra only.

If you go and work outside the Township without the necessary authority, you are liable to be arrested and charged by the authorities controlling that other area.

If you have to travel outside Alexandra then inform the Registering Officer before you leave. He will grant the necessary permission if your request thereto is reasonable and lawful.

Should you become sick or injured and not be able to renew your permit in time, bring a proper medical certificate from a qualified/registered doctor.

Do not send your wife or child or anyone else to come and pay your registration fees. Do it yourself.

Cases are on record where fees have been paid for people who had left Alexandra or died in the meantime.

For your own good, heed these important hints.

Such persons are warned that if they, their lodgers or tenants are found pilfering water from the Board's properties they will be soverely dealt with. Water supply facilities on the Board's properties are intended for the tenants of the Board legally occupying such properties.

The Bulletin makes a request to Malcreants to stop this dirty habit forthwith!

Pay up your water account regularly and hands-off other people's facilities.

Trespassing happens to be a criminal offence, which when added to theft constitutes a formidable proposition for the offender.

And since it is suspected that there must be some connection between water thieving and the malicious damagers damaging the Board's vacant premises these criminals are in for a rough time.

NURSE MARY THEMA

Glowing tributes were paid to Nurse Mary Thema for having completed 25 years unbroken service on the nursing staff of the Alexandra Health Centre and University Clinic when valuable presentations from the Board of Management and Staff of the institution were made to her by the Chairman, Mr. Justice O.D. Schreiner, on the occasion of the Clinic's Annual General Meeting held on the 18th August 1962.

Miss Thema started her career with the clinic during the time of the first Superintendent of the Clinic, Miss Ruth Coles.

In terms of seniority she is second only to the Chairman himself in having been connected with the Clinic since its inception nearly thirty years ago.

Miss Thema does not seem to be much over twenty five years of age and she enjoys the added distinction of having helped at the birth of hundreds of Alexandra babies whose mothers she assisted to bring into the world.

POPULATION OF ALEXANDRA.

The population of Alexandra as shown by figures compiled from the Census conducted in July by officials of the Natives Resettlement Board and of the Peri-Urban Areas Health Board is 56298.

If to this figure is added the 43,016 persons resettled since February 1959, the total is found to exceed 100,000:

In other words, there were more than a tenth of a million men, women and children when the Board took over the administration of Alexandra in 1958.

Of the 56298 now living in the Township 3962 persons are Coloured, together with 63 Asiatics.

MRS. ESTHER CITEKILE NOMASONTO MNGUNI

Several thousand mourners from Alexandra and other parts of the Republic turned up to attend the funeral of Mrs. E.C.N. Mnguni (nee Sibeko) on Saturday 28th July, 1962 the service of which was conducted by the Rev. Father J.R. Namo, Rector of St. Michael's and all Angels Church.

The deceased, who died suddenly on the 21st July, 1962, was the wife of Mr. J. Mnguni, one of Putco's Senior staffdrivers. He was on the way back from Durban on a business trip for the Corporation when his wife died.

At the time of her death at the age of 48 years Mrs. Mnguni held Mary responsible positions on local and National bodies. She was a member of the All-Bantu Executive Committee of

Entokozweni (Entokozweni) Family Welfare Centre; the Executive of the National Council of African Women, the St. Michael's Mothers Union and was Secretary of the local branch of the World's Women Prayer Union, to mention but a few.

Among those who paid tribute to Mrs. Mngunis sterling character and qualities, were: Mrs. Breytenbach of the World's Women's Prayer Union, MR. S.J. MATHEBULA, Chairman of ENTOKOZWENI, MR. P. TLHABANE, Warden of St. Michaels and MR. B.M. MOTAUNG on behalf of the Management and staff of Putco.

OFFICIAL OPENING PHOLOSHO HIGHER PRIMARY SCHOOL

The official opening of the abovementioned school which is situated at No. 3 Square Alexandra will take place on Friday 21st September, 1962 at 10 am.

The Guest Speaker will be Mr. van Dyk, Secretary Bantu Education and the official opening will be performed by Dr. A.S. Bosman, Circuit Inspector of Bantu Education.

It is expected that the Chairman, members and officials of the Peri-Urban Areas Health Board, the Chief Bantu Affairs Commissioner (Witwatersrand Area), the Additional Bantu Affairs Commissioner, Alexandra, officials of the Department of Bantu Administration and Development and Representatives of local and other private and official bodies and undertakings will also attend the function.

PROFESSIONAL SOCCER.

At the time of "going to press" the Alexandra Football Association had not yet taken a decision on the future of professional soccer games in Alexandra. At least, the Bulletin had not been advised.

It is generally known, however, that some of the Senior local clubs are compaigning strongly for the cause of professional soccer which they believe to be an inevitable development even in Alexandra.

The attitude of the Association, however, is that local clubs wishing to do so are free to join the ranks of professional soccer provided their action will not result in restricting the maintenance and promotion of amateur soccer in the Township.

The officials of the Association hold the view that with the capacity of the only two playing-fields in Alexandra already strained to the limit, amateurism may eventually fall become something of the past.

The pro. men, on the other hand, including veteran Soccerite J. BOYANG, among others, contend that only good can come from the change; that local soccer will be tremendously stimulated; that both the residents and the local authority stand to benefit from the money now being spent by Alexandrians

at other centres during week-ends and holidays, and that pro-games will only take place say, once in four or five weeks locally.

NATIVE NOT IN POSSESSION OF REFERENCE BOOK AFTER FIXED DATE.

<u>Section 5(1)</u>: If at any time after the fixed date applicable to him a native attains the age of sixteen years he shall report to a native commissioner, or another officer designated by the Minister, in order that a reference book may be issued to him.

OFFENCES AND PENALTIES.

Section 15(1): Any person -

- (a) being a native who has attained the age of sixteen years, who -
 - (i) after the fixed date applicable to him, is not in possession of a reference book issued to him;
 - (ii) after the fixed date applicable to him fails or refuses to produce on demand of an authorized officer under section thirteen, produces with intent to deceive a reference book which contains any false statement or endorsement or which has been altered in any material respect or which has affixed to it any forged document or stamp;

It is a pleasure to advise you of the success we are experiencing with our Health Promotion Scheme amongst the residents of Alexandra Township. We have found the various Church Groups very receptive and anxious to learn more about correct feeding, budget, and general housecraft. Mrs. Marjorie Koza, who has been lecturing the various groups, is most stimulated by the response. There is also a great interest displayed in learning to form Women's Clubs to increase knowledge and learn practical Arts and Crafts. Towards this end, we are opening the Wynberg Putco Women's Club to include residents of the Township.

Mrs. Koza has been approached by several of the Welfare Organisations in Alexandra to give a lecture on improved diet, but the greater response has come from the religious sects in the Township. In the line of Industrial Feeding, nearly all the factories in this area have been visited by Putco Welfare Officials, and seven have started feeding schemes for their staff. A further dozen are very interested in starting schemes during 1963.

CHRISTMAS MESSAGE BY MR. M. SMUTS, CHIEF BANTU AFFAIRS COMMISSIONER, WITWATERSRAND.

I send my greetings and good wishes to the people of Alexandra.

We have reached the end of another year and it is as well to review what progress has been made in that year. Firstly, the population of Alexandra has again decreased by the removal of families to Diepkloof where conditions are so much better than in Alexandra, and where according to all reports they are very happy.

With the shrinking of the population there has been much more space for the remaining people and crime has decreased.

Unfortunately people from elsewhere saw in the greater availability of accommodation in Alexandra an opportunity to infiltrate illegally into the township. This was never intended. Consequently action had to be taken against these persons, not because the authorities had any wish to do so but because the illegal entry of these persons made it necessary.

Action has been temporarily suspended, to give the people concerned an opportunity to leave Alexandra on their own, particularly during the holiday period. I request them very seriously not to fail in this, because further action will in that event have to be taken.

To the legal inhabitants of Alexandra I say: Please do your utmost to ensure that the holiday period will pass off peacefully and quietly, as ought to be the case in a Christian community. Do this on your own or in co-operation with the authorities.

The Christmas season is not meant for excesses, but rather for quiet remembrance of that great event in which the Christian Church has its origin. May the Christmas season this year be celebrated in that spirit in Alexandra.
