Op 81-12-04 het ek Naidoo, vanaf 16h00 tot 22h35, en die selle te Vereeniging besoek bewaak aangesien hy na bewering dreig om selfmoor te pleeg.

82-10-06

Op 1981-12-04 vanaf 22h35 was myself en S/A/O Smit bemoeid met die ondervraging van Naidoo tot 82-12-06. Vanaf 81-12-07 om 22h00 wa luit. Steyn en myself vermoeid met sy ondervraging tot 81-12-10 Naidoo oorgeplaas is na art. 6 vanaf art. 22.

Sedert 81-12-11 was luit. Steyn en myself bemoeid met die ondervraging van Naidoo om 'n volledige relaas van sy bedrywighede te bekom.

Tydens ondervraging was ek en A/O Smit deuren tyd bymekaar, vanaf 1981-12-07 was ek en luit. Steyn meeste van die tyd bymekaar.

Ek self of niemand anders het ooit vir Naidoo in my teenwoordig aangerand of mishandel nie.

Tydens ondervraging was aan Naidoo koffie, tee en vrugte asook snoeperye voorsien wat ons uit ons sakke aangekoop is. Ons het selfs saam met Naidoo om die beurt koffie en tee gemaak.

Op 'n dag het luit. Steyn my gekonfronteer oor 'n klap, wat ek Nai na bewering sou gegee het. Ek was verbaas en het dit ontken. Ek het Naidoo in die teenwoordigheid van luit. Steyn oor hierdie valse bewering gekonfronteer. Ek het aangebied om hom na 'n lande te neem sodat hy 'n verklaring kan maak, sodat die beweerde aantying ondersoek kan word. Naidoo het my om verskoning gevra en ga hy weet nie waarom hy die bewering gemaak het nie.

Ten tye van die ondervraging was die gesindheid tussen my, Naido A/O Smit en luit. Steyn baie goed. Wanneer hy kla dat hy moeg en vaak is het ons hom laat rus.
