One phase of the struggle passed and another followed but we HAVE NOT FINISHED — one other phase is approaching. The next phase of our struggle is going to be the most difficult and will demand much more organisation and self-sacrifice than we have ever given out before.

The leaders of our organisation are handling the matter in their hands and will from time to time issue out momentous decisions, directives and instructions which it should be our duty to accept and carry out with the minimum of questioning. In that way the struggle will move on, and so will our goal ~~draws close and closer~~ be reached — an Africa free from white domination and exploitation. Whilst we move towards this goal we must form our organisation into a very strong, disciplined and intact organism with its <sup>functional</sup> components, the Senior Congress, Women's Section and Youth League as determined and <sup>active</sup> as possible. The only way to place our organisation on a sound basis in the light of changing environmental conditions, is by devising schemes and methods of organisation which will conform with the pressure from our enemies on one side and with the level of organisation in our branches on the other side. Our method of organisation at the moment is the M-PLAN — a very efficient system if properly put into practice. It is unfortunate that this system of organisation has never been practised on some branches, but where it was practised

it can be said without hesitation that Congress is strongest.  
I am thinking particularly of places like P.L. and E.L. in the  
Cape - Brakpan and Germiston in the Transvaal.

### The MANDELA PLAN (M-PLAN).

Evolved by N.E. as a result of the changed conditions in the political set-up of our country.

- (a) It is a new method of organisation for branches in order to meet the difficulty of convening meetings.
- (b) It answers :-
  - (i) the enrolling of new members.
  - (ii) a regular and constant contact with the masses.

The group, orదద (or block) system formed the basis of what was later called the "Mandela Plan": (M-Plan). We must re-affirm therefore that under the present political conditions in our country, wherein we are in permanent crisis and emergency, the M-Plan should be put into practice if we are to facilitate preparations for any positive action we may be instructed to carry out.

Hence this resolution :-

"That this house re-affirms its belief in the Programme of Action adopted by the A.N.C. with all its phases and what that implies; and recommends that the remaining phases of the Programme of Action be implemented. This house feels however, that the pre-requisite to positive action under the present conditions is the M-PLAN which is a highly mechanised system to unify our Congress branches and to intensify the organisation of all the African people in all areas, (rural and urban).
