I also plan to communicate with members of "Prof's" family, notably his wife, brother, and children.

There are many South African exiles in different parts of the world who knew "Prof." personally. These include political colleagues with whom he was active in the CYL, in the "Africanist Movement," and later in the Pan-Africanist Congress. They will be able to provide useful information.
