1. Directing the Respondent to permit the Applicant to leave the Magisterial District of Kimberley and to travel to Jan Smuts Airport to enable the Applicant to embark on an aircraft leaving the Republic of South Africa pursuant to the departure permit granted in terms of the Departure from the Union Regulation Act No. 34 of 1955 as amended;
2. That the Respondent pay the costs of this Application;
3. Allowing other or alternative relief;

and that the accompanying Affidavit of ROBERT MANGALISO SOBUKWE will be used in support thereof.

TAKE NOTICE FURTHER that the Applicant has appointed the offices of Messrs. Segal & Seymore, 301 J.B.S. Building, Bureau Lane, Pretoria, at which he will accept notice and service of all process in these proceedings.

TAKE NOTICE FURTHER that if you intend opposing this application you are required :

- (a) to notify Applicant's attorneys in writing on or before the 16th day of April, 1971;
- (b) and within fourteen (14) days of the service of your notice of intention to oppose, to file your answering affidavits, if any; and further that you are required to appoint in such notification an address within five (5) miles of the office of the registrar at which you will accept notice and service of all documents in these proceedings.

If no such notice of intention to oppose be given, the application will be made on the 11th day of May, 1971, at 10 a.m.
