INTRODUCTION

MR PRESIDENT AND GENTLEMEN -

It is my pleasure to present to you my first, the TRANSVAAL SOCCER BOARD's 45th Secretarial Report.

I will endeavour to present the activities of the Board for the year under review. It is however, necessary to make a few comments and observations first.

The lack of meaningful commitments from a few units and executive members within the Board, placed the burden and responsibility of the administration of the Board onto a few individuals. Despite the suspicion and mistrust created by negative press articles and rumours spread by elements trying to fragment the Board; the leadership has successfully overcome these and proved these rumours to be untrue and totally groundless.

In spite of the many obstacles the leadership had to contend with, the year under review has proved to be the best year the Board and all its affiliates has seen for years. The progress made has never been achieved in a single year prior to 1984.

A number of our administrators need to reassess their commitment to the struggle. The SOUTH AFRICAN SOCCER FEDERATION in its quest for equality and justice for a non-racial society are constantly victims of the State's policy to destroy all the non-racial sports bodies in South Africa, and in turn promote their own policy of Multinationalism. The nature of the South African political order is one of oppression, exploitation and the policy of Apartheid. No other Country in the world has legislation which entrenches discrimination in sport and society on the basis of colour. Sport and politics have therefore become inextricably intertwined as a direct result of the political policies of the WHITE oppressor. Ministerial concessions relating to sport were frequently announced without changing the basic structure and functioning of the political system. The position of the oppressed has therefore not changed at all. We are forced to use mediocre sports facilities,

makeshift and rudimentary facilities created by our people. Circumstances such as these make it virtually impossible to participate and administer sport in this Country.

In order to make a contribution to the organizations we belong to, our sincerity and commitment to the struggle needs rejuvenation and reawakening.

Let us join hands for a United battle for LIBERATION.

MEMBERSHIP

The membership of the TRANSVAAL SOCCER BOARD comprises of 6 (six) district affiliates namely:

1. B F A - Bosmont Football Association
2. EPFA - Eldorado Park Football Association
3. ETFA - Eastern Transvaal Football Association
4. FETFA - Far Eastern Transvaal Football Association
5. LFA - Lenasia Football Association
6. PDFFA - Pretoria Districts Football Association

Transvaal Second Division League details of which appears further on in this report. Transvaal Referees Association are associate members, details of which appear further on in this report.

The Board also wishes to initiate the membership of the Transvaal High and Primary School Sports Associations.

ADMINISTRATION OF THE BOARD:

At a Council Meeting of the Board on the 4 July 1984, the General Secretary - Mr Kollopen resigned. Mr M A Kahn was elected to this position at the same meeting.

All matters concerning the Board were dealt with as promptly as possible. Affiliates were always kept fully aware of the activities of the Board. The scheduling of the Inter District and Second Division League fixtures, and the lack of control in the registration of players are three problems the Board could definitely improve on in the forthcoming season. Other than these a fairly high standard of administration was achieved by the Executive.

In addition, the acquisition of an office in February 1985, will introduce the beginning of a very high standard of administration for the Board.

ADMINISTRATION OF DISTRICT UNITS

Some affiliates conducted their administration in a credible manner; while the functioning of others leave much to be desired. It is of utmost importance that units ask for assistance when they do find it difficult to deal with problems, as a result of lack of manpower or expertise.

I must emphasize the need for all our affiliates to maintain a high standard of administration in the face of our opposition.

MEETINGS

Since the Annual General Meeting on 12 February 1984, Council Meetings were held. All meetings were generally well attended although it was apparent that some units refused to send senior Executive members to the Council meetings. As a result, deliberations at times were not of the required standard because delegates did not have an open mandate from their respective units.

Executive meetings were called regularly to deal with routine matters. These meetings were normally well attended.

INTER-DISTRICT FIXTURES

The Inter-District fixtures for 1984 was not completed. It was apparent that better planning and scheduling of these fixtures was needed. We must however, remain mindful of the significance of these games. These games are the highlight for many of our juniors as well as seniors, and they deserve the right to be credited with the honour of playing for their particular district and perhaps eventually for their Province.

It was sad to note that selection problems at district level was prevalent. Teams were merely chosen to fulfil inter-district games and not truly representative of the best talent available within the district. This however, causes serious selection problems for the senior TRANSVAAL SOCCER BOARD representative team. Bear in mind that in 1985, an Under 18 has to be selected to participate in the SOUTH AFRICAN SOCCER FEDERATION Junior Tournament in Port Elizabeth.

DISTRICT TOURNAMENTS

a) PRETORIA DISTRICTS' FOOTBALL ASSOCIATION TOURNAMENT

The development of the elements working to destroy us forced the Pretoria Districts Football Association to stage a tournament in opposition to the planned activities of the collaborationists and opportunists in the Pretoria Districts' Football Association Area. It was uplifting to find that the Pretoria Districts Football Association received unconditional support from all the district units at such very short notice. A show of strength as displayed will serve to inspire the rank and file in the non-racial struggle. We commend the Pretoria Districts Football Association for their stand, and for their opposition to these collaborators and promoters of multinationalism. It is important that principles of non-racial sport be taught to young sportspersons in order to develop a sound foundation for the future.

b) EASTERN TRANSVAAL JUNIOR TOURNAMENT - UNDER 14

The TRANSVAAL SOCCER BOARD was delighted to grant permission to the Eastern Transvaal Football Association to stage a Junior Tournament during October 1984. My most sincere thanks to the Eastern Transvaal Football Association for taking the initiative to stage a Junior Tournament. Tournaments are the highlight of any sport.

Your Association is to be complimented on the organizing of this Tournament as well as for the informative brochure produced.

SOUTH AFRICAN SOCCER FEDERATION PROVINCIAL TOURNAMENT

In September 1984, the TRANSVAAL SOCCER BOARD hosted the SOUTH AFRICAN SOCCER FEDERATION 1984 Inter-Provincial Tournament.

It was a proud moment for the TRANSVAAL SOCCER BOARD to have been honoured with the opportunity to host the "Last" centralised SOUTH AFRICAN SOCCER FEDERATION Inter-Provincial Tournament. Future tournaments will be decentralised.

Despite the various problems the TRANSVAAL SOCCER BOARD executive were faced with in the organising of the tournament, I can say with confidence that these problems were overcome. The Tournament on the whole was a great success; the TRANSVAAL SOCCER BOARD was complimented on this by various units of the Board. (The finance will be dealt with in the Financial Statement).

The TRANSVAAL SOCCER BOARD team completed the tournament fourth best. A great improvement on recent years, despite the problems the coach faced; i.e. players capable of demanding their place in the team, not making themselves available for selections, the squad being finalised at a very late stage, inadequate time to prepare the team fully, injury as a result of players commitments to their teams, demanding schedule of fixtures prior to the Tournament.

The absence of some units senior officials at the Tournament was felt by many; especially players representing the TRANSVAAL SOCCER BOARD, who sometimes feel that their talents

and contributions to the game are seldom appreciated by their own district associations and district officials.

The board would like to take this opportunity to thank Mr I Bagaria and Mr E Patel for all their assistance as coaches of the Board for the 1984 Inter-Provincial Tournament. We hope that the relationship between the Board and the coaches will grow from strength to strength. We also wish to thank all the players selected for the sacrifices made in order to participate.

SOUTH AFRICAN SOCCER FEDERATION KNOCKOUT CUP COMPETITION

The SOUTH AFRICAN SOCCER FEDERATION Knockout Cup was initiated in 1983, as an added incentive for the League and Knockout Cup Champions of the different SOUTH AFRICAN SOCCER FEDERATION affiliates. In 1984 the first two draws were done on a regional basis i.e., Transvaal, Griqualand West and Orange Free State. As the Orange Free State did not renew their membership of the SOUTH AFRICAN SOCCER FEDERATION, Transvaal played against Griqualand West.

The TRANSVAAL SOCCER BOARD League champions - Young Eagles played Diamond Park (Griqualand West) in Laudium and won, one goal to nil. Young Eagles second game was against Spades Football Club (Griqualand West) they lost one goal to nil. Senior TRANSVAAL SOCCER BOARD officials present at this game felt that Young Eagles did not prepare themselves properly.

The TRANSVAAL SOCCER BOARD Cup Champions - Bluebells United travelled to Kimberley to play Diamond Park during August 1984. Unfortunately the game was abandoned as a result of spectators of Diamond Park interfering with the Bluebells players. The matter was referred to the SOUTH AFRICAN SOCCER FEDERATION. In September the SOUTH AFRICAN SOCCER FEDERATION took a decision that the game should be replayed in Kimberley. The TRANSVAAL SOCCER BOARD President liaised with the SOUTH AFRICAN SOCCER FEDERATION President telephonically in this regard. It was agreed that Bluebells were prepared to forfeit the game to be replayed in Kimberley.

Battswood Football ^{CLUB} of WESTERN PROVINCE SOCCER BOARD beat Spades Football Club of Griqualand West in the final of the SOUTH AFRICAN SOCCER FEDERATION Knockout Cup Competition.

## TRANSVAAL REFEREES ASSOCIATION

The Transvaal Referees Association is Associate members and are responsible for the control of referees in the Transvaal - Second Division League, and the F P L games in the Transvaal.

There were serious misgivings about the competency of the Referees Association from the offset of the 1984 season. It was abundantly clear that elements within the Referees Association were trying their utmost to create disunity and fragment both the TRANSVAAL SOCCER BOARD and the TRANSVAAL REFEREES ASSOCIATION, by misconstruing facts and relaying these untruths to loyal members of the two organisations. As a result of this the game was brought into disrepute. The T S B second division league was forced to appeal to district units to officiate their games. Even the F P L was blackmailed at the end of the season when they refused to reverse decisions the TRANSVAAL REFEREES ASSOCIATION were unhappy with. Are we going to allow this situation to continue?

In serving the needs of our members and those in the non racial fold, it is most disgusting to find seasoned administrators as these who choose to disregard the true reasons for being administrators, and also our principles and policies which guide us all in the non racial struggle. We do not need these hypocrites amongst us.

## TRANSVAAL SENIOR SCHOOL SPORTS ASSOCIATION AND TRANSVAAL PRIMARY SCHOOLS SPORTS ASSOCIATION

It is disappointing to note that the Transvaal High and Primary School Sports Associations, are still not members of the TRANSVAAL SOCCER BOARD. Almost 80% of all scholars playing in the Board attend schools affiliated to these bodies.



There is no doubt that the SPORTS UNION OF TRANSVAAL SCHOOLS (SUTS), a creation of SAONGA are making desperate attempts to gain international recognition, and are also inturn trying to destroy the SOUTH AFRICAN SENIOR SCHOOLS SPORTS ASSOCIATION (SASSA) and the SOUTH AFRICAN PRIMARY SCHOOLS SPORTS ASSOCIATION (SAPSSA). This becomes all the more necessary for the TRANSVAAL SOCCER BOARD, TRANSVAAL SENIOR SCHOOLS SPORTS ASSOCIATION and TRANSVAAL PRIMARY SCHOOLS SPORTS ASSOCIATION to form a strong working relationship.

#### SOUTH AFRICAN COUNCIL ON SPORT AND TRANSVAAL COUNCIL ON SPORT

The TRANSVAAL SOCCER BOARD remains a member of the TRANSVAAL COUNCIL ON SPORT. The TRANSVAAL COUNCIL ON SPORT and the TRANSVAAL SOCCER BOARD recently hosted a very successful presentation function at Cathedral Place - (details appear in this report).

It is, however, most disturbing to find that despite the decision by the Board, that all district units should affiliate to TRACOS individually, some units have not done so. Units that did affiliate however, do not attend TRACOS meetings regularly.

TRACOS was also responsible for the recent unity between SOUTHERN TRANSVAAL FOOTBALL UNION and LENASIA FOOTBALL ASSOCIATION - we thank them most sincerely.

TRACOS is the provincial unit of the SOUTH AFRICAN COUNCIL ON SPORT, who is the vanguard of non racial sport in South Africa.

It is also very sad to find that senior officials of some of our units are not prepared to participate in the activities of TRACOS, but are however, prepared to sit back and criticise some of the principles of SACOS. I wonder if they fully understand these principles. If exposing injustice in sport, in a country riddled with racialism and laws that deprive



you of your basic human rights is wrong, then I would rather be that. Our commitment and contribution to the struggle should not be superficial, there should be no hypocrites among us.

#### SOUTH AFRICAN SOCCER FEDERATION

At the Annual General Meeting of the SOUTH AFRICAN SOCCER FEDERATION on 14 July 1984 in Port Elizabeth, Mr R K Reddy was returned to serve the SOUTH AFRICAN SOCCER FEDERATION for the next two years as President.

It is pleasing to note that at last the SOUTH AFRICAN SOCCER FEDERATION has become progressive, in that attempts are being made to do more for the players within the SOUTH AFRICAN SOCCER FEDERATION i.e., SASF Junior Competition and National Coaching.

To achieve all their objectives the SOUTH AFRICAN SOCCER FEDERATION needs all the support of all members. For the TRANSVAAL SOCCER BOARD to extend itself to the SOUTH AFRICAN SOCCER FEDERATION more enthusiasm is needed from all the Board's units.

#### COACHES

All the affiliates of the SOUTH AFRICAN SOCCER FEDERATION have been encouraged to start their own Coaching Academy. It has become absolutely necessary to embark on such a project for the good of the game.

We are very proud to mention that the 1984 TRANSVAAL SOCCER BOARD Coach - Mr I Bagaria is instrumental in the launching of a National Coaching Academy for the SOUTH AFRICAN SOCCER FEDERATION.



We are fortunate in the Transvaal to have a number of coaches with some of the best credentials in the SOUTH AFRICAN SOCCER FEDERATION, they however, were not utilised. The TRANSVAAL SOCCER BOARD has never before made an attempt to organise coaching clinics. This matter should be treated with great urgency.

#### ANNUAL RETURNS

To date all affiliates have not submitted their Annual Returns. It is sad to note the returns received were received late.

I do hope that during 1985 the returns will be submitted timeously and accurately. Affiliates should give this matter their serious attention.

#### DEFECTORS

During 1983, the SOUTH AFRICAN SOCCER FEDERATION decided that defectors whose reinstatements has been approved must serve a waiting period of three months before he is allowed to play. It was also decided that defectors not be allowed to our matches and functions.

The SOUTH AFRICAN SOCCER FEDERATION Council is presently considering a request that a final deadline be set and thereafter NO DEFECTORS should be accepted. This would put an end to the continuous embarrassment defectors cause the SOUTH AFRICAN SOCCER FEDERATION.

Units should note that any DEFECTORS can only be reinstated by the SOUTH AFRICAN SOCCER FEDERATION. These reinstatements are done on the recommendations of the SOUTH AFRICAN SOCCER FEDERATION provincial units and the F P L.

The TRANSVAAL SOCCER BOARD recommended the reinstatement of two DEFECTORS during 1984.




CONCLUSION

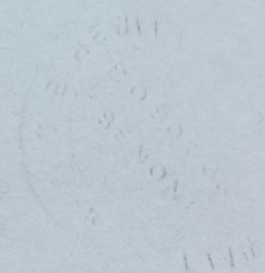

TRANSVAAL SOCCER BOARD  
FOR THE YEAR ENDED 31ST JANUARY 1985

We have examined the annual financial statements set out on pages 2 to 4. Other than as explained in the following paragraph, our examination included such auditing procedures as we considered necessary.

In common with similar organisations, it is not feasible for the association to institute accounting controls over cash collections from donations prior to the initial entry of the collections in the accounting records. Furthermore the constitution of the association and the minutes were not supplied for audit. Accordingly it was impracticable for us to extend our examination beyond the receipts actually recorded as well as the legitimacy of the running of the association.

Subject to the effects of any adjustments which might have been necessary had it been possible for us to extend our examination, in our opinion the financial statements fairly present the financial position of the association at 31 January 1985 and the results of its operations for the year then ended in accordance with generally accepted accounting practice.
