## COMMENTS ON DRAFT EVIDENCE TO VOTE COMMISSION

- Page 1: Assumptions: These in fact, are incorrect all groups are not concerned with advancing 'Western Christian civilisation' e.g.

  Indians, Malays, Jews, etc. "Western Christian Civilisation" also a misstatement.
  - (b) All groups do <u>not</u> believe in democracy: Many favour oligarchy or totalitarianism.

Incorrect assumptions vitiate argument. Therefore suggest cut out assumptions up to "Civilisation means a moral and political order.....personality." Omit "It also involves the belief" and substitute "In a Christian country such civilization will be informed..." etc.

- Page 2: For "The second assumption" put "Democracy involves the acceptance of the recognition....."

  Paragraph 2, Line 5: change to "white minority group, culturally more mature..."
  - Line 13: for "superior" put "more advanced"
  - Line 14: for "cultural superiority" put "cultural difference"

# Page 3: Paragraph 1:

- 6 lines from bottom "South Africa itself has seen"
- 5 " " 1910 instead of 1909
- 4 " " 1910 instead of 1909.
- 5 lines from bottom the establishment of a differentiated "but common franchise" must be elucidated; what does it mean?

# Paragraph 2:

"People with power.....logical consequences of that giving (on page

4)" This section is not relevant; is felt not to advance the argument; suggest it be repritten. The question set up on page 2 is not answered on page 3 or 4

Line 5: for "finds many justifications" substitute "finds many arguments in justification."

- Page 4: For "but the fact is that such power is shared" 5 line sfrom top substitute "nevertheless the general tendency in Africa outside the
  Union has been increasingly to share such power".

  Paragraph 1: Line 5 should read "to dispel such fear especially where
  it is irrational and unfounded and to give outlets"

  Paragraph 3: "representation of the cape Coloured people in South..."
  2 lines from bottom Ordinance
- Page 5: Paragraph 1: Line 6 1835 should be 1853.

  Paragraph 2: Last line 1909 should be 1910.

  Paragraph 3: Line 1 should read "In the northern territories, namely the Transvaal, the Orange Free State...."

  Line 5 ".....including the Coloured....."
- Page 6: Paragraph 1: Last line: 1909 should be 1910.

  Line 5 put "subject to the special Code of Native Law"

  Line 7 ".....nothing in these laws affected the

  Coloured people or those Africans who were not under the Code of Native

  Law..."
- Page 7: No alterations.
- Page 8: Paragraph 2: (a) "has had and probably still has members belonging to all political parties"
  - (f) omit reference to assumptions.
- Page 14: Paragraph 3: Line 9 omit "and Muslims".
