The Bishop of Southern Rhodesia moved and Mr. S.G. Raddall seconded.

(a) That a Church Weekly Newspaper be inaugurated, provided no financial responsibility falls on the Church of the Province other than the grant recommended in (c).

The Bishop of Southern Rhodesia moved and Mr. Cockerill seconded.

(b) That the Editor be given a free hand to produce the best possible publication with such resources, materials, and support as may be at his disposal.

The Bishop of Southern Rhodesia moved and Archdeacon Harris seconded.

(c) That a grant of £400 for the first year, and £200 for each of the two subsequent years be made to be divided proportionately among the Dioceses of the Province, but excluding the Dioceses of St. Helena and Lebombo. Canon Cardross Grant moved) Archdeacon Harris seconded) amendment to insert after "made" the words "by the Provincial Standing Committee when satisfied that such grant is justified".

Archdeacon Urquhart moved) The Dean of Pretoria seconded) an amendment to read for "proportionately" the words "in proportion to the circulation of the paper in that Diocese" Leave given to withdraw the amendment.

The Resolution as amended was then put and carried.

The Bishop of Southern Rhodesia moved and Captain Wood seconded omitting words here struck out.

(d) That the safeguards in respect of ownership, control of policy, appointment of editor, etc. as set forth in this memorandum to apply, in-this-interim-arrangement.

The Bishop of Southern Rhodesia moved and Mr. Raddall seconded.

- (e) That the newspaper be published weekly with a minimum of eight pages and a circulation of 10,000 copies, subject to:
 - (i) The Archbishop's right to appoint and dismiss the Editor.
 - (11) the foundation of a Proprietary Company.
 - (111) that the Articles of Association of the Proprietary Company secure for the Archbishop the inalienable control of the policy.

The Bishop of Southern Rhodesia moved and Canon Ledley Brown seconded (omitting "to")

(f) That Supplement be incorporated as opportunities present themselves on condition that existing undertakings in this regard be honoured.

The Bishop of Southern Rhodesia moved and Mr. S.G. Raddall seconded.

(g) That the resolution of the 1924 Session of Provincial Synod concerning the Church Chronicle be rescinded and that steps be taken with a view to the amalgamation of the "Church Chronicle" and the Church Weekly Newspaper.

Resolved that negotiations with the "Church Chronicle" be left to the President in consultation with the Committee of the "Church Chronicle".

Resolved

That the whole scheme as presented by the Committee receive general approval.
